**DECISION AND ORDER**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 upon the Claimant's request for a hearing. After due notice, a telephone hearing was held on [REDACTED] Claimant and a witness [REDACTED] appeared and testified. The Department was represented by [REDACTED]

**ISSUE**

Did the Department properly deny Claimant's Medical Assistance (MA) application?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. Claimant applied for MA-P on [REDACTED] a request for retroactive coverage back to [REDACTED].
2. The Medical Review Team denied the application on [REDACTED].
3. Claimant filed a request for hearing on [REDACTED] regarding the MA denial.
4. A telephone hearing was held on [REDACTED]
5. On [REDACTED] the State Hearing Review Team denied the application effective [REDACTED] because the Claimant's does retains the capacity to perform light exertional work.
6. Claimant was approved for Social Security Disability benefits with an onset date of [REDACTED]

7. The Department agreed at hearing to active coverage going back to [REDACTED] [REDACTED]

### CONCLUSIONS OF LAW

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (DHS or department) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (BRM).

Department policy at BEM 260 states that if a claimant has been found eligible by the State Hearing Review Team, the person meets the Department's MA disability criteria. No other evidence is required to establish disability. In the present case, the claimant was found disabled by the Social Security Administration and has presented prima facie evidence of the same. This disability was found by the Social Security Administration to be disabled as of [REDACTED] [REDACTED] 2. Therefore, the Administrative Law Judge finds that the Claimant met the Department's definition of disabled for the purposes of MA-P.

### DECISION AND ORDER

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that the Claimant is medically disabled as of [REDACTED] [REDACTED] for the purposes of the MA and retroactive MA program, pending a review of all non-medical eligibility factors. The Department representatives agreed to this at hearing.

Accordingly, the Department's decision in the above stated matter is, hereby, **REVERSED.**

The Department is **ORDERED** to process Claimant's Medicaid and Retroactive Medicaid applications of [REDACTED] [REDACTED] [REDACTED] and initiate a review of all non-medical eligibility factors, if it has not already done so.

The Department is further **ORDERED** to initiate a full review of this case in [REDACTED]
