**CONSENT ORDER OF DISMISSAL AS TO FOOD ASSISTANCE PROGRAM
BENEFITS ONLY**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on April 25, 2013, from Detroit, Michigan. Participants on behalf of Claimant included the Claimant. Participants on behalf of the Department of Human Services (Department) included [REDACTED], Medical Contact Worker.

The Michigan Administrative Code R 400.903(1) provides as follows:

An opportunity for a hearing shall be granted to an applicant who requests a hearing because his claim for assistance is denied or is not acted upon with reasonable promptness, and to any recipient who is aggrieved by an agency action resulting in suspension, reduction, discontinuance, or termination of assistance.

In this case, on no date, the Department


- denied Claimant's application for benefits

- reduced Claimant's benefits

Claimant requested a hearing to dispute the Department's FAP action. Shortly after commencement of the hearing, Claimant testified he now understood and accepted the actions taken by the Department. Claimant also testified he did not wish to proceed with a hearing on the FAP issue. The Department agreed to the dismissal of Claimant's FAP hearing request. Pursuant to MAC R 400.906(1), Claimant's hearing request is hereby DISMISSED with regard to Food Assistance Program benefits only.

Based on the above discussion, it is ORDERED that this matter is DISMISSED with regard to Food Assistance Program benefits only, pursuant to MAC R 400.906(1).
