**DECISION AND ORDER**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 42 C.F.R. § 431.200 *et seq.*, upon the Appellant's request for a hearing.

After due notice, a hearing was held on [REDACTED]. [REDACTED] appeared and testified on Appellant's behalf. Appellant was also present but did not testify. [REDACTED], Appeals Review Officer, represented the Department of Community Health. [REDACTED], Adult Services Worker (ASW) from the [REDACTED] County DHS [REDACTED] District Office, appeared as a witness for the Department. [REDACTED] Adult Services Supervisor was also present but did not testify.

**ISSUE**

Did the Department properly deny Appellant's request for Home Help Services (HHS)?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. Appellant is a [REDACTED]-year-old [REDACTED] Medicaid beneficiary. (Testimony).
2. Appellant has been diagnosed with being mentally challenged, having anxiety disorder and back pain. (Exhibit A, p. 13).
3. The ASW testified at the hearing the Appellant's physician completed a Medical Needs Form, a DHS-54A, indicating that Appellant had a medical need for assistance only with meal preparation, shopping, laundry, and housework. (Testimony).
4. On [REDACTED], the ASW, did a home visit with the Appellant and did a face-to-face assessment to determine Appellant's eligibility for HHS. The ASW determined that Appellant did not meet the criteria for HHS as she did not need hands on assistance with any of her ADLs. (Exhibit A, p. 13 and testimony).

5. On [REDACTED], the Department issued an Adequate Action Notice to Appellant informing her that HHS would be denied based on the policy effective [REDACTED] that requires the need for hands on assistance with at least one ADL to be eligible for HHS, and Appellant's recent assessment did not identify a need for assistance with any ADLs. (Exhibit A, pp. 6-7, 9-12 and testimony).
6. On [REDACTED], MAHS received Appellant's Request for Hearing. The request for hearing indicates a need for assistance with household chores, cooking, and managing her financial affairs. (Exhibit A, pp. 4-5).

**CONCLUSIONS OF LAW**

The Medical Assistance Program is established pursuant to Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). It is administered in accordance with state statute, the Social Welfare Act, the Administrative Code, and the State Plan under Title XIX of the Social Security Act Medical Assistance Program.

Home Help Services (HHS) are provided to enable functionally limited individuals to live independently and receive care in the least restrictive, preferred settings. These activities must be certified by a physician and may be provided by individuals or by private or public agencies.

Adult Services Manual 101 (11-1-2011) (hereinafter "ASM 101") and Adult Services Manual 120 (11-1-2011) (hereinafter "ASM 120") address the issues of what services are included in Home Help Services and how such services are assessed:

**Home Help Payment Services**

Home Help Services are non-specialized personal care service activities provided under the independent living services program to persons who meet eligibility requirements.

Home Help Services are provided to enable individuals with functional limitation(s), resulting from a medical or physical disability or cognitive impairment to live independently and receive care in the least restrictive, preferred settings.

Home Help Services are defined as those tasks which the department is paying for through Title XIX (Medicaid) funds. These services are furnished to individuals who are **not** currently residing in a hospital, nursing facility, licensed foster care home/home for the aged, Intermediate Care Facility (ICF) for persons with developmental disabilities or institution for mental illness.

These activities must be certified by a Medicaid enrolled medical professional and may be provided by individuals or by private or public agencies. **The medical professional does not prescribe or authorize personal care services.** Needed services are determined by the comprehensive assessment conducted by the adult services specialist.

Personal care services which are eligible for Title XIX funding are limited to:

Activities of Daily Living (ADL)

- Eating.
- Toileting.
- Bathing.
- Grooming.
- Dressing.
- Transferring.
- Mobility.

Instrumental Activities of Daily Living (IADL)

- Taking medication.
- Meal preparation/cleanup.
- Shopping for food and other necessities of daily living.
- Laundry.
- Housework.

An individual must be assessed with at least One Activity of Daily Living (ADL) in order to be eligible to receive Home Help Services.

**Note:** If the assessment determines a need for an ADL at a level 3 or greater but these services are not paid for by the department, the individual would be eligible to receive IADL services.

**Example:** Ms. Smith is assessed at a level 4 for bathing however she refuses to receive assistance. Ms. Smith would be eligible to receive assistance with IADL's if the assessment determines a need at a level 3 or greater. [ASM 101, pages 1-2 of 4].

**Services not Covered by Home Help Services**

Home help services must **not** be approved for the following:

- Supervising, monitoring, reminding, guiding of encouraging (functional assessment rank 2). [ASM 101, page 3 of 4].

**Functional Assessment**

The **Functional Assessment** module of the **ASCAP** comprehensive assessment is the basis for service planning and for the HHS payment.

Conduct a functional assessment to determine the client's ability to perform the following activities:

Activities of Daily Living (ADL)

- Eating
- Toileting
- Bathing
- Grooming
- Dressing
- Transferring
- Mobility

Instrumental Activities of Daily Living (IADL)

- Taking Medication
- Meal Preparation and Cleanup
- Shopping
- Laundry
- Light Housework

Functional Scale

ADL's and IADL's are assessed according to the following five-point scale:

1. **Independent:** Performs the activity safely with no human assistance.
2. **Verbal Assistance:** Performs the activity with verbal assistance such as reminding, guiding or encouraging.

3. **Some Human Assistance:** Performs the activity with some direct physical assistance and/or assistive technology.
4. **Much Human Assistance:** Performs the activity with a great deal of human assistance and/or assistive technology.
5. **Dependent:** Does not perform the activity even with human assistance and/or assistive technology.

Home Help Payments may only be authorized for needs assessed at the 3 level or greater.

An individual must be assessed with at least One Activity of Daily Living in order to be eligible to receive home help services.

**Note:** If the assessment determines a need for an ADL at a level 3 or greater but these services are not paid for by the department, the individual would be eligible to receive IADL services.

**Example:** Ms. Smith is assessed at a level 4 for bathing however she refuses to receive assistance. Ms. Smith would be eligible to receive assistance with IADL's if the assessment determines a need at a level 3 or greater.

See ASM 121, Functional Assessment Definitions and Ranks for a description of the rankings for activities of daily living and instrumental activities of daily living. [ASM 120, pages 2-3 of 6].

Here, the ASW testified she sent out an Adequate Negative Action Notice to the Appellant indicating that her request for HHS would be denied based on the policy effective [REDACTED], that requires the need for hands on assistance with at least one ADL to be eligible for HHS, and Appellant's recent assessment did not identify a need for assistance with any ADLs. (See Exhibit A, pp. 6-7, 9-12). The ASW stated on [REDACTED], she did a home visit with the Appellant and did a face-to-face assessment to determine Appellant's eligibility for HHS. She determined the Appellant did not meet the criteria for HHS as she did not need assistance with any of her ADLs.

The ASW stated she met with the Appellant and Appellant told her she bathes, dresses, grooms, takes her own medication, cleans up, cooks most of her meals, shops and does most of her laundry. When the ASW asked what kind of help she needed the Appellant stated she only needed help with laundry, because she gets nervous sometimes. The ASW stated the Appellant was able to walk around the apartment, and the ASW determined she did not need to use an assistive device to get around

The ASW testified the Medical Needs form, the DHS-54A completed by the Appellant's doctor and submitted along with the Appellant's application, indicates that the Appellant only had a medical need for assistance with meal preparation, shopping, laundry, and housework.

The ASW referenced the policy on eligibility for HHS, (ASM 120, page 3 of 5), and stated HHS may only be authorized for needs assessed at the 3 level or greater and that an individual must be assessed with at least one activity of daily living in order to be eligible to receive HHS. The ASW concluded that this policy supported the negative action she took in this case.

During the hearing, Appellant's witness indicated she did not understand why the Appellant was denied HHS. The Appellant's witness testified the Appellant does need services, she takes her to the doctor, helps with her laundry sometimes, cooks some complete meals for the Appellant, helps her clean the house, takes her to the grocery store and shopping, and helps the Appellant with her medication. Appellant's witness acknowledged that the Appellant could bathe herself.

The preponderance of reliable evidence in this case demonstrates that at the time of the ASW's assessment, and according to the Medical Needs form from her doctor, the Appellant did not need assistance with any of her ADLs. According to the policy quoted above, an individual is only eligible to receive HHS if she has a need for assistance with an ADL at a level 3 or greater. See ASM 101, page 2 of 4; ASM 120, page 3 of 6. Appellant had demonstrated no such need at the time of her assessment and was properly found to be ineligible to receive any type of HHS. Accordingly, the Department's decision must be sustained.

**DECISION AND ORDER**

The Administrative Law Judge, based on the above findings of fact and conclusions of law, finds that the Department properly denied Appellant's request for HHS.
