**HEARING DECISION**

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and MCL 400.37 following Claimant's request for a hearing. After due notice, a telephone hearing was held on July 24, 2013, from Detroit, Michigan. Participants on behalf of Claimant included Claimant. Participants on behalf of the Department of Human Services (Department) included [REDACTED].

**ISSUE**

Did the Department properly deny Claimant's March 25, 2013, application for Medical Assistance (MA) and State Disability Assistance (SDA)?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On March 25, 2013, Claimant applied for MA and SDA.
2. On April 15, 2013, the Department sent Claimant a medical packet requesting that medical documents necessary to establish the disability be completed and submitted by April 25, 2013.
3. Claimant did not timely submit the requested documents.
4. On April 29, 2013, the Department sent Claimant a Notice of Case Action denying his application on the basis that he had failed to return documentation necessary to complete the disability determination.

5. On May 7, 2013, Claimant filed a request for hearing disputing the Department's denial of his MA and SDA application.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT).

The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10, *et seq.*, and MCL 400.105.

The State Disability Assistance (SDA) program, which provides financial assistance for disabled persons, is established by 2004 PA 344. The Department of Human Services (formerly known as the Family Independence Agency) administers the SDA program pursuant to MCL 400.10, *et seq.*, and Mich Admin Code, R 400.3151 through R 400.3180.


Additionally, Claimant applied for SDA and MA benefits on March 25, 2013, alleging a disability. On April 15, 2013, the Department sent Claimant a Medical Determination Verification Checklist (VCL) requesting that Claimant submit a completed medical packet. On April 29, 2013, the Department sent Claimant a Notice of Case Action denying the application because Claimant had failed to submit requested verifications by the April 25, 2013, due date.

At the hearing, Claimant was unable to establish that he submitted any of the requested medical verifications prior to May 24, 2013. While Claimant credibly testified at the hearing that he had difficulties reading and writing and had previously notified the Department of this issue, it did not appear that Claimant requested assistance with respect to gathering the VCL documents in the instant case. See BAM 105 (September 2012), p. 10; BAM 130 (May 2012), p. 1. In the absence of Claimant's request for assistance in connection with the current application or VCL and in light of his failure to provide the requested documents prior to the April 29, 2013, Notice of Case Action denying his application, the Department acted in accordance with Department policy when it denied Claimant's MA and SDA application.

### **DECISION AND ORDER**

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, finds that the Department acted in accordance with Department policy when it denied Claimant's SDA and MA application.

Accordingly, the Department's decision is AFFIRMED.

**NOTICE OF APPEAL:** Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request. (60 days for FAP cases).

The claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely Request for Rehearing or Reconsideration was made, within 30 days of the receipt date of the Decision and Order of Reconsideration or Rehearing Decision.

A Request for Rehearing or Reconsideration may be granted when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The Department, AHR or the claimant must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date the hearing decision is mailed.
