HEARING DECISION FOR INTENTIONAL PROGRAM VIOLATION

Upon the request for a hearing by the Department of Human Services (Department), this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16, and with Mich Admin Code, R 400.3130 and R 400.3178. After due notice, a telephone hearing was held on December 17, 2013 from Lansing, Michigan. The Department was represented by Regulation Agent of the Office of Inspector General (OIG).

Respondent did not appear at the hearing and it was held in Respondent's absence pursuant to 7 CFR 273.16(e), Mich Admin Code R 400.3130(5), or Mich Admin Code R 400.3178(5).

<u>ISSUES</u>

- 2. Did Respondent, by clear and convincing evidence, commit an Intentional Program Violation (IPV)?
- 3. Should Respondent be disqualified from receiving ☑ Food Assistance Program (FAP)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

 The Department's OIG filed a hearing request on September 23, 2013, to establish an OI of benefits received by Respondent as a result of Respondent having allegedly committed an IPV.

- The OIG ⋈ has requested that Respondent be disqualified from receiving program benefits.
 Respondent was a recipient of ⋈ FAP benefits issued by the Department.
 Respondent ⋈ was aware of the responsibility to report all changes in circumstances within 10 days of those changes occurring.
- 5. Respondent had no apparent physical or mental impairment that would limit the understanding or ability to fulfill this requirement.
- 6. The Department's OIG indicates that the time periods it is considering the fraud periods are April 1, 2011 to June 30, 2011 and October 1, 2011 to May 31, 2012 (fraud period). The Respondent's unreported income was in excess of the simplified reporting limit during these times.
- 7. During the fraud period of April 1, 2011 to June, 30 2011, Respondent was issued \$\frac{1}{2}\$ in \$\subseteq\$ FAP benefits by the State of Michigan, and the Department alleges that Respondent was entitled to \$\frac{1}{2}\$ in such benefits during this time period.
- 8. During the fraud period of October 1, 2011 to May 31, 2012, Respondent was issued \$ in \infty FAP benefits by the State of Michigan, and the Department alleges that Respondent was entitled to \$ in such benefits during this time period.
- 9. There was no fraud period between June 30, 2011 and October 1, 2011, as the Respondent's income did not put her over the simplified reporting limit.
- 11. This was Respondent's ⊠ first alleged IPV.
- 12. A notice of hearing was mailed to Respondent at the last known address and ⊠ was not returned by the US Post Office as undeliverable.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT). Prior to August 1, 2008, Department policies were contained in the Department of Human Services Program Administrative Manuals (PAM), Department of Human Services Program Eligibility Manual (PEM), and Department of Human Services Reference Schedules Manual (RFS).

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, PL 104-193, and 42 JSC 601 to 679c. The Department (formerly known as the Family Independence Agency) administers FIP pursuant to MCL 400.10 and 400.57a and Mich Admin Code, R 400.3101 to .3131.
The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 271.1 to 285.5. The Department (formerly known as the Family Independence Agency) administers FAP oursuant to MCL 400.10 and Mich Admin Code, R 400.3001 to .3015.
The Medical Assistance (MA) program is established by the Title XIX of the Social Security Act, 42 USC 1396-1396w-5, and is implemented by 42 CFR 400.200 to 1008.59. The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10 and MCL 400.105.
The State Disability Assistance (SDA) program is established by the Social Welfare Act, MCL 400.1119b. The Department of Human Services (formerly known as the Family Independence Agency) administers the SDA program pursuant to MCL 400.10 and Mich Admin Code, R 400.31513180.
The Child Development and Care (CDC) program is established by Titles IVA, IVE and XX of the Social Security Act, 42 USC 601-619, 670-679c, and 1397-1397m-5; the Child Care and Development Block Grant of 1990, PL 101-508, 42 USC 9858 to 9858q; and the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, PL 04-193. The program is implemented by 45 CFR 98.1-99.33. The Department administers the program pursuant to MCL 400.10 and provides services to adults and children pursuant to MCL 400.14(1) and Mich Admin Code, R 400.50015020.

The Department's OIG requests IPV hearings for the following cases:

- FAP trafficking OIs that are not forwarded to the prosecutor,
- prosecution of welfare fraud or FAP trafficking is declined by the prosecutor for a reason other than lack of evidence, and
 - the total OI amount for the FIP, SDA, CDC, MA and FAP programs is sor more, or
 - the total OI amount is less than \$ and
 - > the group has a previous IPV, or
 - > the alleged IPV involves FAP trafficking, or
 - > the alleged fraud involves concurrent receipt of assistance (see BEM 222), or

the alleged fraud is committed by a state/government employee.

BAM 720 (2011), p. 10.

Intentional Program Violation

Suspected IPV means an OI exists for which all three of the following conditions exist:

- The client intentionally failed to report information or intentionally gave incomplete or inaccurate information needed to make a correct benefit determination, and
- The client was clearly and correctly instructed regarding his or her reporting responsibilities, and
- The client has no apparent physical or mental impairment that limits his or her understanding or ability to fulfill reporting responsibilities.

BAM 700 (2011), p. 6; BAM 720, p. 1.

An IPV is also suspected for a client who is alleged to have trafficked FAP benefits. BAM 720, p. 1.

An IPV requires that the Department establish by clear and convincing evidence that the client has intentionally withheld or misrepresented information for the **purpose** of establishing, maintaining, increasing or preventing reduction of program benefits or eligibility. BAM 720, p. 1 (emphasis in original); see also 7 CFR 273(e)(6). Clear and convincing evidence is evidence sufficient to result in a clear and firm belief that the proposition is true. See M Civ JI 8.01.

In this case, the Department has established that the Respondent failed to report being in her home at the time she signed her DHS-1171, Assistance Application. had SSI income that was therefore not being budgeted because the Respondent failed to report that he was in her home. The Respondent also failed to report her return to work from maternity leave, again resulting in income not being budgeted for FAP. The evidence establishes that the Respondent's omissions were intentional, as she completed and signed three DHS-1171, Assistance Applications wherein she acknowledge her responsibility to report all changes in household circumstances within 10 days of those changes occurring. Those DHS-1171, Assistance Applications were signed on 4/6/11, 5/26/11 and 2/3/12. Yet the Respondent failed to mention ' presence in her home on any of those applications though he had been in her home since and she failed to mention her return to work. The Administrative Law Judge does therefore conclude that the Respondent did commit her first IPV.

Disqualification

A court or hearing decision that finds a client committed IPV disqualifies that client from receiving program benefits. BAM 720, p. 12. A disqualified recipient remains a member of an active group as long as he lives with them, and other eligible group members may continue to receive benefits. BAM 720, p. 13. Clients who commit an IPV are disqualified for a standard disqualification period except when a court orders a different period, or except when the OI relates to MA. BAM 720, p. 13. Clients are disqualified for periods of one year for the first IPV, two years for the second IPV, lifetime disqualification for the third IPV, and ten years for a FAP concurrent receipt of benefits. BAM 720, p. 16. In this case, the Administrative Law Judge has determined that the Respondent committed her first IPV and she will therefore be subject to a one year personal disqualification from the FAP.

Over-issuance

When a client group receives more benefits than they are entitled to receive, the Department must attempt to recoup the OI. BAM 700, p. 1.

In this case, the Respondent's violation began the day she signed her first DHS-1171, Assistance Application because she failed to accurately report her household composition on that day. The Department has therefore accurately determined that the OI periods are from 4/1/11 to 6/30/11 and 10/1/11 to 5/31/12. A close examination of the OI budgets in evidence reveals that the Department has properly calculated the total OI to be \$\frac{1}{2}\$

DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, concludes that:

- 1. Respondent ⊠ did commit an IPV by clear and convincing evidence.
- 2. Respondent ⊠ did receive an OI of program benefits in the amount of \$ from the following program(s) ⊠ FAP.

The Department is ORDERED to \boxtimes initiate recoupment procedures for the amount of in accordance with Department policy.

X	It is FURTHER	ORDERED tha	t Respondent be disqualified from ⊠ FAP for a period
of	\boxtimes 12 months.	24 months.	☐ lifetime.
