HEARING DECISION

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on December 12, 2013, from Detroit, Michigan. Participants on behalf of Claimant included Claimant. ISSUE

Did the Department properly deny Claimant's applications for the Family Independence Program (FIP) and State Emergency Relief (SER) for rent?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On June 20, 2013, Claimant applied for FIP benefits.
- 2. On September 25, 2013, the Department sent Claimant a notice of case action informing her that her FIP application was approved effective August 1, 2013, and scheduled to close October 1, 2013, due to Claimant having reached the federal time limit.
- On September 18, 2013, Claimant applied for SER for rent. 3.

- 4. On September 18, 2013, the Department sent Claimant an SER decision notice informing Claimant that her application for SER was denied because the rent was deemed unaffordable.
- 5. On September 26, 2013, Claimant requested a hearing to protest the Department's denial of her FIP and SER applications.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, PL 104-193, and 42 USC 601 to 679c. The Department (formerly known as the Family Independence Agency) administers FIP pursuant to MCL 400.10 and 400.57a and Mich Admin Code, R 400.3101 to .3131.

The State Emergency Relief (SER) program is established by the Social Welfare Act, MCL 400.1-.119b. The SER program is administered by the Department (formerly known as the Family Independence Agency) pursuant to MCL 400.10 and by Mich Admin Code, R 400.7001 through R 400.7049.

FIP Application

The Department's reliance on Claimant's having reached the federal time limit fails because the Department failed to provide documentation of the months counted toward Claimant's receipt of these benefits toward the federal time limit.

The failure of the Department to include the months counted toward the federal time limit made it impossible for Claimant to review the Department's basis for closing her FIP case due to reaching the federal time limit.

SER Application

The Department's calculation of Claimant's affordability for the rent SER was not provided.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department

acted in accordance with Department policy when it

did not act in accordance with Department policy when it

S failed to satisfy its burden of showing that it acted in accordance with Department policy when it closed Claimant's FIP case and denied Claimant's SER application.

DECISION AND ORDER

Accordingly, the Department's decision is

- \boxtimes THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:
- 1. Reinstate Claimant's FIP benefits back to October 1, 2013, and supplement for any missed benefits.
- 2. Return to the September 18, 2013, SER application date, recalculate the affordability of Claimant's rent and issue a new SER decision notice if appropriate.

NOTICE OF APPEAL: The claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely Request for Rehearing or Reconsideration was made, within 30 days of the receipt date of the Decision and Order of Reconsideration or Rehearing Decision.

Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request (60 days for FAP cases).

A Request for Rehearing or Reconsideration may be granted when one of the following exists:

Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;

- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The Department, AHR or the claimant must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date the hearing decision is mailed.
