HEARING DECISION

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99. 1 to 99.33; and 45 CFR 205.10. notice, an in person hearing was held on F ebruary 20, 2014, fr om Ypsilanti, Michigan. Participants on behalf of Claimant incl uded Claimant's Aut horized Hearings Representative from Participants on behalf of the Department of Human Services (Department) included and

ISSUE

Did the Department properly process Claimant's MA benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on t he competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Claimant was born May 27, 2010.
- 2. SSI/MA was approved on July 31, 2010 e ffective June 1, 2010, May 2010 was incorrectly not included.
- 3. The Department opened coverage on April 11, 2013 but May 2010 was the only month included in the exception.
- 4. The Claimant's Representative waited until coverage was activated to bill for June and July 2010 because the billing rules don't allow for multiple billings.
- 5. Claimant's Authorized Hearings Represent ative requested hearing on November 12, 2013

CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Service s Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), D epartment of Human Service es Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Medic al Assistance (MA) program is est ablished by the Title XIX of the Socia I Security Act, 42 USC 1396-1396w-5, and is implemented by 42 CFR 400.200 to 1008.59. The Department of Human Services (formerly known as the Family Independence Agency) administers the MA program pursuant to MCL 400.10 and MCL 400.105.

Additionally, Claimant was born on June 2010. Claimant should have been approved beginning the month of her birth, May 2010. Claimant's Authorized Representative waited to bill until c overage was active for the correct months. When the Department corrected the error in April 2013 they only processed the exception for May 2010 but Claimant's Representative had not submitted bills for June and July 2010 because the billing rules required that all bills be processed at the same time. Claimant's Representative requested at hearing that an exception be processed to allow billing for the entire service period which is what should have happened from the beginning.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not act in accordance wit h Department policy when it failed to include coverage for May 2010 and when it did not allow billing for May, June and July 2010.

DECISION AND ORDER

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WIT H DE PARTMENT P OLICY AND CONSIS TENT WIT H THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

- 1. Activate coverage for May, June, and July 2010.
- 2. Issue an MSA 1038 and any other required documents to process coverage for May, June, and July 2010.

NOTICE OF APP EAL: The claimant may appea I the Dec ision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, i f a timely Request for Rehearing or Reconsiderati on was made, within 30 days of the receipt date of the Decision and Order of Reconsideration or Rehearing Decision.

Michigan Administrative Hearing S ystem (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a par ty within 30 days of the mailing date of this Dec ision and Order. MAHS will not order a rehearing or reconsideration on the Department's mo tion where the final decis ion cannot be implemented within 90 days of the filing of the original request (60 days for FAP cases).

A Request for Rehearing or Reconsideration may be granted when one of the following exists:

- Newly disc overed evidence that existed at the time of the or iginal hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;

 Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The Department, AHR or the clai mant must specify all reas ons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date the hearing decision is mailed.
