### **HEARING DECISION**

After due notice, telephone hearing was held on Wednesday, February 26, 2014, from Lansing, Michigan. Participants on behalf of Claimant included the Claimant. Participants on behalf of the Department of Human Services (Department) included ES.

## ISSUE

#### FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, including testimony of witnesses, finds as material fact:

- 2. Claimant was required to submit requested verification by January 2, 2014.
- 3. On January 16, 2014, the Department ⊠ denied Claimant's application.
- 4. On January 16, 2014, the Department sent Claimant notice of its action.
- 5. On January 27, 2014, Claimant filed a hearing request, protesting the Department's action.

# **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT).

☑ The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 271.1 to 285.5. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10 and Mich Admin Code, R 400.3001 to .3015.

Additionally, the Claimant applied for FAP on December 16, 2013. On December 23, 2013, the Department Caseworker sent the Claimant a Verification Checklist for written verification of what was due January 2, 2013. Department Exhibit's 13-14. The Claimant failed to provide the required verification by the due date of January 2, 3013. As a result, the Department Caseworker sent the Claimant a notice on January 16, 2014 that FAP would be denied due to failure to provide verification. Department Exhibit's 15-19. BEM 502 and 504. BAM 105, 115, 130, 200, 210, and 220.

The Department has met their burden that the Claimant's FAP application should be denied because the Claimant failed to provide the required verification to determine FAP eligibility.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any finds that the Department acted in accordance with Department policy when it denied the Claimant's FAP application for failure to provide the required verifications to determine FAP.

# **DECISION AND ORDER**

Accordingly, the Department's decision is  $\boxtimes$  AFFIRMED.

**NOTICE OF APPEAL**: The Claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely Request for Rehearing or Reconsideration was made, within 30 days of the receipt date of the Decision and Order of Reconsideration or Rehearing Decision.

Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request (60 days for FAP cases).

A Request for Rehearing or Reconsideration may be granted when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The Department, AHR or the Claimant must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date the hearing decision is mailed.
