

## **HEARING DECISION**

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a three way telephone hearing was held on March 6, 2014, from Detroit, Michigan. Participants on behalf of Claimant included the Claimant. Participants on behalf of the Department of Human Services (Department) included **Exercise**, ES.

## **FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material, and substantial evidence on the whole record, including testimony of witnesses, finds as material fact:

2. Claimant was required to submit requested verification by January 2, 2014.

- On February 1, 2014, the Department
  ☐ denied Claimant's application.
  ☐ closed Claimant's case.
  ☐ reduced Claimant's benefits.
- 4. On January 16, 2014, the Department sent Claimant/Claimant's Authorized Representative (AR) notice of its action.
- 5. On February 4, 2014, Claimant/Claimant's Authorized Hearing Representative (AHR) filed a hearing request, protesting the Department's action.

## CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT).

∑ The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 271.1 to 285.5. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10 and Mich Admin Code, R 400.3001 to .3015.

Additionally, this hearing involves whether the Department properly closed the Claimant's FAP case when it did not receive the redetermination packet by the due date and thereafter before the closure date of February 1, 2014. The Department presented evidence that it did not receive the redetermination paperwork and accordingly sent a Notice of Missed Interview dated January 15, 2014. Exhibit 2. The Claimant confirmed receipt of the redetermination packet and the Notice of Missed Interview. The Claimant and the Department exchanged emails and the Claimant was informed on January 28, 2014, before case closure, that she would have to resubmit the redetermination. The Claimant testified that although she had a copy she did not do so, and also made no attempt to fax the information to the Department. Based upon these facts it is determined that the Department properly closed the Claimant's Food Assistance case because it did not receive the redetermination information requested prior to case closure and thus could not conduct an interview. BAM 130 (7/1/13).

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any finds that the Department

acted in accordance with Department policy when it closed Claimant's food assistance case when it did not receive the verification by the verification due date or prior to case closure.

## **DECISION AND ORDER**

Accordingly, the Department's decision is

AFFIRMED.

**NOTICE OF APPEAL:** The claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely Request for Rehearing or Reconsideration was made, within 30 days of the receipt date of the Decision and Order of Reconsideration or Rehearing Decision.

Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request (60 days for FAP cases).

A Request for Rehearing or Reconsideration may be granted when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The Department, AHR or the claimant must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date the hearing decision is mailed.
