HEARING DECISION

Upon a hearing request by the Department of Human Services (Department) to establish an overissuance (OI) of benefits to Respondent, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, 400.43a, and 24.201, *et seq.*, and Mich Admin Code, R 400.941, and in accordance with 7 CFR 273.15 to 273.18, 42 CFR 431.200 to 431.250, 45 CFR 99.1 to 99.33, and 45 CFR 205.10. After due notice, a telephone hearing was held on March 11, 2014, from Lansing, Michigan. Participants on behalf of the Department included [REDACTED] Recoupment Specialist.

Initially, the Respondent had not appeared when the telephone hearing began. This matter having been initiated by the Department and due notice having been provided to Respondent, the hearing was held in Respondent's absence in accordance with Department of Human Services Bridges Administrative Manual (BAM) 725 (7-1-2013), pp. 15-22.

Respondent called in shortly after the conclusion of the initial hearing proceedings. Therefore, continued hearing proceedings were held the same date, March 11, 2014. Participants on behalf of Respondent included [REDACTED], the Respondent.

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Respondent was a recipient of ☒ FIP ☒ FAP ☐ SDA ☐ CDC benefits from the Department.

2. The Department alleges Respondent received a

CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT).

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, PL 104-193, and 42 USC 601 to 679c. The Department (formerly known as the Family Independence Agency) administers FIP pursuant to MCL 400.10 and 400.57a and Mich Admin Code, R 400.3101 to .3131.

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 271.1 to 285.5. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10 and Mich Admin Code, R 400.3001 to .3015.

When a client group receives more benefits than it is entitled to receive, DHS must attempt to recoup the overissuance (OI). BAM 700, p 1 (7-1-2013). An overissuance (OI) is the amount of benefits issued to the client group or CDC provider in excess of what it was eligible to receive. For FAP benefits, an OI is also the amount of benefits trafficked (traded or sold). BAM 700, p 1 (7-1-2013).

An agency error OI is caused by incorrect action (including delayed or no action) by DHS staff or DIT staff or department processes. BAM 700, p 4 (7-1-2013). If unable to identify the type of OI, the Department records it as an agency error. BAM 700, p 4 (7-1-2013).

A client error OI occurs when the client received more benefits than they were entitled to because the client gave incorrect or incomplete information to the department. BAM 700, p 6 (7-1-2013).

A Claimant must report changes in circumstance that potentially affect eligibility or benefit amount. Changes must be reported within 10 days of receiving the first payment reflecting the change. BAM 105, p.7 (5-1-2012).

Client and Agency error OIs are not pursued if the estimated OI amount is less than \$250 per program. BAM 700, p 9 (7-1-2013).

Here, the Department contends that Respondent received OIs of FIP and FAP benefits due to an agency error. Specifically, the Department asserts that the Department failed to timely and properly re-determine Respondent's FIP and FAP eligibility after Respondent's timely reporting of income from Durand Senior Center. It was uncontested that the Respondent reported earnings to the Department in August and November 2012. The Department's failure to timely re-determine the Respondent's eligibility when employment earnings were reported resulted in a FIP benefits OI of \$[REDACTED] and a FAP benefits OI of \$[REDACTED]

As noted above, it is not disputed that Respondent reported the employment income to the Department. Pursuant to BAM 700, recoupment is pursued for OIs greater than \$250, even when it was the Department's error that caused the OI.

This Administrative Law Judge has carefully considered and weighed the testimony and other evidence in the record. The evidence of record shows that the Department did err when it failed to timely re-determine Respondent's FIP and FAP eligibility after Respondent reported employment earnings in August and November 2012. The FIP OI period is November 1, 2012, through January 31, 2013 and the FAP OI period is October 1, 2012, through December 31, 2012. When the income from the Respondent's employment was included in the FIP and FAP budgets, the difference between the benefit amounts the Respondent received and the benefit amounts the Respondent was entitled to receive was \$[REDACTED] for FIP and \$[REDACTED] for FAP. Accordingly, the total OI still due and owing to the Department is \$[REDACTED]

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, finds that the Department did establish ☒ FIP ☒ FAP ☐ SDA ☐ CDC benefit OIs to Respondent totaling \$[REDACTED]

DECISION AND ORDER

Accordingly, the Department is **AFFIRMED**.

The Department is ORDERED to initiate collection procedures for \$ [REDACTED] of OIs in accordance with Department policy.

NOTICE OF APPEAL: The claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely Request for Rehearing or Reconsideration was made, within 30 days of the receipt date of the Decision and Order of Reconsideration or Rehearing Decision.

Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request (60 days for FAP cases).

A Request for Rehearing or Reconsideration may be granted when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The Department, AHR or the claimant must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date the hearing decision is mailed.
