HEARING DECISION FOR INTENTIONAL PROGRAM VIOLATION

Upon the request for a hearing by the Department of Human Services (Department), this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16, and with Mich Admin Code, R 400.3130 and R 400.3178. After due notice, a telephone hearing was held on April 29, 2014 from Lansing, Michigan. The Department was represented by Coffice of Inspector General (OIG).

Respondent did not appear at the hearing and it was held in Respondent's absence pursuant to 7 CFR 273.16(e), Mich Admin Code R 400.3130(5), or Mich Admin Code R 400.3178(5).

ISSUES

- 2. Did Respondent, by clear and convincing evidence, commit an Intentional Program Violation (IPV)?
- 3. Should Respondent be disqualified from receiving ☑ Food Assistance Program (FAP)?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

 The Department's OIG filed a hearing request on January 15, 2014, to establish an OI and debt collection of benefits received by Respondent as a result of Respondent having allegedly committed an IPV.

2.	The OIG \boxtimes has requested that the Respondent be disqualified from receiving program benefits.			
3.	Respondent was a recipient of $\ \ \Box$ FIP $\ \ \boxtimes$ FAP $\ \ \Box$ SDA $\ \ \Box$ CDC $\ \ \Box$ MA benefits issued by the Department.			
4.	Respondent \boxtimes was aware of the responsibility to not engage in unauthorized transactions.			
5.	Respondent had no apparent physical or mental impairment that would limit the understanding or ability to fulfill this requirement.			
6.	The Department's OIG indicates that the time period it is considering the fraud period is July 1, 2005 through July 31, 2006.			
7.	During the fraud period, Respondent was issued \$ in ☐ FIP ☒ FAP ☐ SDA ☐ CDC ☐ MA benefits by the State of Michigan.

CONCLUSIONS OF LAW				
Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT). Prior to August 1, 2008, Department policies were contained in the Department of Human Services Program Administrative Manuals (PAM), Department of Human Services Program Eligibility Manual (PEM), and Department of Human Services Reference Schedules Manual (RFS).				
☐ The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 271.1 to 285.5. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10 and Mich Admin Code, R 400.3001 to .3015.				

The Department's OIG requests IPV hearings for the following cases:

• FAP trafficking OIs that are not forwarded to the prosecutor,

- prosecution of welfare fraud or FAP trafficking is declined by the prosecutor for a reason other than lack of evidence, and
 - the total OI amount for the FIP, SDA, CDC, MA and FAP programs is \$ or more, or
 - the total OI amount is less than \$ and
 - the group has a previous IPV, or
 - the alleged IPV involves FAP trafficking, or
 - the alleged fraud involves concurrent receipt of assistance (see BEM 222), or
 - the alleged fraud is committed by a state/government employee.

BAM 720 (7-1-2013), p. 12.

Intentional Program Violation

Suspected IPV means an OI exists for which all three of the following conditions exist:

- The client intentionally failed to report information or intentionally gave incomplete or inaccurate information needed to make a correct benefit determination, and
- The client was clearly and correctly instructed regarding his or her reporting responsibilities, and
- The client has no apparent physical or mental impairment that limits his or her understanding or ability to fulfill reporting responsibilities.

BAM 700 (7-1-2013), p. 7; BAM 720, p. 1.

An IPV is also suspected for a client who is alleged to have trafficked FAP benefits. BAM 720, p. 1.


An IPV requires that the Department establish by clear and convincing evidence that the client has intentionally withheld or misrepresented information for the purpose of establishing, maintaining, increasing or preventing reduction of program benefits or eligibility. BAM 720, p. 1; see also 7 CFR 273(e)(6). Clear and convincing evidence is evidence sufficient to result in a clear and firm belief that the proposition is true.



In this case, the Department has established that Respondent was aware of the responsibility to timely and accurately report to the Department all household changes, including changes with income. Department policy requires clients to report any change in circumstances that will affect eligibility or benefit amount within 10 (ten) days. BAM 105 (7-1-2009).

Simplified Reporting groups are required to report when the group's actual gross monthly income (not converted) exceeds the Simplified Reporting income limit for their group size.

If the group has an increase in income, the group must determine their total gross income at the end of that month. If the total gross income exceeds the group's Simplified Reporting income limit, the group must report this change to their specialist by the 10th day of the following month, or the next business day if the 10th day falls on a weekend or holiday. BAM 200 (12-1-13) pp. 1, 5 and 6.





There was no evidence showing that Respondent timely and accurately reported this change in income to the Department within 10 days as required per policy. In addition, Respondent had no apparent physical or mental impairment that limited her understanding or ability to fulfill these reporting responsibilities. Accordingly, the Department has established the Respondent committed an IPV by clear and convincing evidence.

Disqualification

A court or hearing decision that finds a client committed IPV disqualifies that client from receiving program benefits. BAM 720, p. 15. A disqualified recipient remains a member of an active group as long as he lives with them, and other eligible group members may continue to receive benefits. BAM 720, p. 15.

Clients who commit an IPV are disqualified for a standard disqualification period except when a court orders a different period, or except when the OI relates to MA. BAM 720, p. 13. Refusal to repay will not cause denial of current or future MA if the client is otherwise eligible. BAM 710 (7-1-2013), p. 2. Clients are disqualified for periods of one year for the first IPV, two years for the second IPV, lifetime disqualification for the third IPV, and ten years for a FAP concurrent receipt of benefits. BAM 720, p. 16.

In this case, the evidence of record shows that Respondent committed her first IPV which carries a 12 month disqualification.

Over-issuance

In this case, the Respondent was issued \$ in FAP benefits by the State of Michigan during the fraud period. The Department re-calculated the FAP budgets considering the unreported income and determined that Respondent was only entitled to \$ of such benefits during the fraud period. The evidence of record shows that Respondent received an OI of FAP benefits during the above-mentioned fraud period in the amount of \$ 100 of FAP benefits during the state of the period in the second state of the period state of the period in the second state of the period state of the period

DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, concludes that:

1.	The Department has established by clear and convincing evidence that Respondent \boxtimes did commit an intentional program violation (IPV).
2.	Respondent did receive an OI of program benefits in the amount of from the following program(s) FIP FAP SDA CDC MA.
	Department is ORDERED to \boxtimes initiate recoupment procedures for the amount of in accordance with Department policy.
	It is FURTHER ORDERED that Respondent be disqualified from \Box FIP $oxtimes$ FAPSDA \Box CDC for a period of $oxtimes$ 12 months.
