# HEARING DECISION

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on June 18, 2014, from Detroit, Michigan. Participants on behalf of Claimant included Claimant. Participants on behalf of the Department of Human Services (Department) included

### <u>ISSUE</u>

Did the Department properly deny Claimant's application for Food Assistance Program (FAP), Medical Assistance (MA) and State Disability Assistance (SDA) benefits?

### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On January 9, 2014, Claimant applied for FAP, MA, and SDA.
- 2. On January 13, 2014, the Department sent Claimant an appointment notice for January 16, 2014.
- 3. On January 13, 2014, the Department sent Claimant a verification checklist requesting various pieces of information.
- 4. On January 16, 2014, the Department sent Claimant a medical determination verification checklist.
- 5. On January 31, 2014, the Department sent Claimant a notice of case action informing her that her FAP had been approved beginning January 9, 2014, and

that her MA and SDA applications had been denied for failure to supply the requested verifications.

6. On May 12, 2014, Claimant requested a hearing to protest the denial of her MA and SDA applications, and the amount of FAP benefits approved.

### CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Family Independence Agency) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

The State Disability Assistance (SDA) program is established by the Social Welfare Act, MCL 400.1-.119b. The Department of Human Services (formerly known as the Family Independence Agency) administers the SDA program pursuant to 42 CFR 435, MCL 400.10 and Mich Admin Code, R 400.3151-.3180.

Claimant had applied for MA based on disability and for cash assistance through SDA benefits. The Department testified that Claimant had failed to provide documentation of the medical disability alleged by Claimant. BAM 130 (April 2014).

In addition to Claimant's failure to provide documentation of disability, the hearing revealed that Claimant had a pension plan from Henry Ford Health System that provided Claimant with access to \$7,280.41. Claimant testified that the \$7,280.41 was, in fact, available to her due to the ending of her employment.

This information places Claimant over the asset limit for all of the programs for which she applied (i.e., SDA limit - \$3,000.00; FAP limit - \$5,000.00; MA limit - \$2,000.00. BEM 400 (December 2013).

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department

Acted in accordance with Department policy when it denied Claimant's application for FAP, MA, and SDA..

did not act in accordance with Department policy when it

failed to satisfy its burden of showing that it acted in accordance with Department policy when it

**NOTICE OF APPEAL:** A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of this Hearing Decision, or MAHS may order a rehearing or reconsideration on its own motion.

MAHS may grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the
  outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;

• Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.
