HEARING DECISION

<u>ISSUE</u>

Did the Department properly deny claimant's SER application?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Claimant applied for SER on April 15, 2014.for home repair, specifically for a clogged sewer.
- 2. On May 1, 2014, Claimant requested a hearing and asked for assistance with a clogged sewer and for furnace repairs.
- 3. On February 4, 2014, all sewer repairs at issue were made and paid for.
- 4. On March 11, 2014, all furnace repairs at issue were made and paid for.
- 5. At the time Claimant's hearing request, both repairs had been made.
- 6. Claimant did not request SER for the furnace repair on his application and only requested assistance with the furnace repair when he requested his hearing.

7. Claimant requested hearing on May 1, 2014.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The State Emergency Relief (SER) program is established by the Social Welfare Act, MCL 400.1-.119b. The SER program is administered by the Department (formerly known as the Family Independence Agency) pursuant to MCL 400.10 and by Mich Admin Code, R 400.7001 through R 400.7049.

Additionally, State Emergency Relief is only available regarding home repairs to resolve an emergency and is not available when the repairs have already been performed. ERM 102, 103, 304. Here, all repairs have been done.

Notably, the furnace repairs were not requested on the application, so the Administrative Law Judge lacks jurisdiction to address this issue. However, this distinction is moot because the home repairs at issue have been completed.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied the SER application.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.

NOTICE OF APPEAL: A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of this Hearing Decision, or MAHS may order a rehearing or reconsideration on its own motion.

MAHS may grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
