AMENDED HEARING DECISION

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on July 10, 2014, from Lansing, Michigan. Participants on behalf of Claimant included [REDACTED], Regulation Agent of the Office of Inspector General (OIG). Respondent did not appear at the hearing and it was held in Respondent's absence pursuant to 7 CFR 273.16(e), Mich Admin Code R 400.3130(5), or Mich Admin Code R 400.3178(5).

At the conclusion of the hearing, a Hearing Decision was issued by Administrative Law Judge Kevin Scully and mailed on July 21, 2014, which is hereby **AMENDED** to correct the programs affected.


FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Finding of fact #3 in the original Hearing Decision dated July 21, 2014, is corrected indicate that the Respondent was a recipient of FAP and SDA, and not FAP and CDC.
2. Order #3 in the original Hearing Decision dated July 21, 2014, should indicate that the Respondent did receive an OI of program benefits in the amount of \$ [REDACTED] from the following program(s) SDA, and not CDC.
3. Order #5 in the original Hearing Decision dated July 21, 2014, should indicate that the Respondent be disqualified from FAP and SDA for a period of 12 months, and not FAP and CDC.

4. All other Findings of Fact and Conclusions of Law contained in the original Hearing Decision dated July 21, 2014, remain unchanged and are incorporated herein by reference.

NOTICE OF APPEAL: A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of this Hearing Decision, or MAHS may order a rehearing or reconsideration on its own motion.

MAHS may grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
