## **HEARING DECISION**

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on August 26, 2014, from Lansing, Michigan. # **ISSUE**

Did the Department properly close the Claimant's Food Assistance Program (FAP) benefits due to excess assets?

## FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. The Claimant was an ongoing Food Assistance Program (FAP) recipient.
- 2. On July 16, 2014, the Department notified the Claimant that it would close his Food Assistance Program (FAP) benefits effective August 1, 2104, due to excess assets.
- 3. On July 25, 2014, the Department received the Claimant's request for a hearing, protesting the closure of his Food Assistance Program (FAP) benefits.

#### CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is

implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

Assets means cash, any other personal property and real property. Real property is land and objects affixed to the land such as buildings, trees and fences. Condominiums are real property. Personal property is any item subject to ownership that is not real property. Countable assets cannot exceed the applicable asset limit. An asset is countable if it meets the availability tests and is not excluded. Available means that someone in the asset group has the legal right to use or dispose of the asset. Department of Human Services Bridges Eligibility Manual (BEM) 400 (October 1, 2013), pp 1-7.

The Claimant was an ongoing Food Assistance Program (FAP) recipient when the Department determined that he had countable assets totaling \$ which is in excess of the \$ asset limit for the FAP program. On July 16, 2014, the Department notified the Claimant that it would close his Food Assistance Program (FAP) benefits as of August 1, 2014.

The Claimant testified that one bank account the Department determined to be a countable assets contains overages from student loans.

The Department determined that the assets are countable as educational income that is an excludable asset for only 1 month.

The Department defines educational income as income received for educational purposes, e.g., grants, fellowships, scholarships, veterans educational benefits and certain student educational loans. Department of Human Services Bridges Policy Glossary (BPG) (July 1, 2014), pp 22.

The Department excludes current income from countable assets. BEM 400, p 20. The Department excludes income from countable assets in the month that it is received. BEM 400, p 20. Funds set aside for educational expenses are excluded from countable assets. BEM 400, p 22.

The Claimant possess a bank account with a balance of \$ which puts his total countable assets over the \$ limit. These funds are defined as educational income because they are the proceeds of a student educational loan. They are not excludable as current income or educational savings because the Claimant has been out of school for a year.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined that the Claimant's countable assets and closed his Food Assistance Program (FAP) benefits due to excess assets.

# **DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.

**NOTICE OF APPEAL:** A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of this Hearing Decision, or MAHS may order a rehearing or reconsideration on its own motion.

MAHS may grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
