# HEARING DECISION

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on November 20, 2014, from Detroit, Michigan. Participants on behalf of Claimant included Claimant. # <u>ISSUE</u>

Did the Department properly close Claimant's Family Independence Program (FIP) benefits case?

# FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On October 1, 2014, the Department sent Claimant a notice of noncompliance with work-related activities.
- 2. On October 9, 2014, the Department held a triage with Claimant and found no good cause for Claimant's absence from work-related activities.
- 3. On October 1, 2014, the Department sent Claimant a notice of case action informing her that her FIP benefits were scheduled to terminate on November 1, 2014.
- 4. On October 21, 2014, Claimant requested a hearing to protest the Department's closure of her FIP benefits case.

# CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Pub. L. No. 104-193, and 42 USC 601 to 679c. The Department (formerly known as the Family Independence Agency) administers FIP pursuant to 45 CFR 233-260, MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3101 to .3131.

At the hearing, Claimant testified that she had an altercation with the father of her child. This caused her health problems and she was unable to attend the scheduled workrelated activities.

This Administrative Law Judge asked Claimant if she had documentation of a physician finding that she could not participate in work-related activities. Claimant responded that she did not have such documentation.

This Administrative Law Judge finds that the Department was correct in finding no good cause for Claimant's missing work-related activities. BEM 233A (October 2014).

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department

- acted in accordance with Department policy when it closed Claimant's FIP benefits case effective November 1, 2014.
  - did not act in accordance with Department policy when it
- failed to satisfy its burden of showing that it acted in accordance with Department policy when it .

**NOTICE OF APPEAL:** A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of this Hearing Decision, or MAHS may order a rehearing or reconsideration on its own motion.

MAHS may grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.
