**HEARING DECISION**

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on June 9, 2014, from Detroit, Michigan. Participants on behalf of Claimant included Claimant. Participants on behalf of the Department of Human Services (Department) included ██████████

**ISSUE**

Did the Department properly deny Claimant's application for Food Assistance Program (FAP) benefits?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Claimant applied for FAP benefits.
2. Claimant was incarcerated in the ██████████ from January 27, 2014, through March 26, 2014.
3. On March 27, 2014, the Department sent Claimant a notice of case action informing him that the Department was denying his application for FAP benefits.
4. On May 8, 2014, Claimant requested a hearing to protest the denial of his FAP benefits.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

At the hearing, the Department presented documentation that Claimant had been incarcerated through March 26, 2014.

The Department cites BEM 265, stating that, because he was in incarcerated for more than 30 days, the Department must deny his FAP application. The Department policy as outlined in BEM 265 prohibits the granting of FAP benefits to an individual who resides in an institution that provides food for the individuals who reside there.

In the instant case, Claimant was incarcerated from January 27, 2014, through March 26, 2014. The Department is correct in denying Claimant FAP benefits during the time of his incarceration. However, this Administrative Law Judge can find no policy that continues to deny a previously incarcerated individual after the incarceration is over. Departmental policy includes a lifetime prohibition from FAP for an individual that has been convicted at least two times of drug-related felonies since 1996. This is not the case here; there is no policy that would continue to deny Claimant FAP benefits after his incarceration was over. BEM 265 (October 2013).

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department

- acted in accordance with Department policy when it .
- did not act in accordance with Department policy when it denied Claimant's FAP application.
- failed to satisfy its burden of showing that it acted in accordance with Department policy when it .


### **DECISION AND ORDER**

Accordingly, the Department's decision is

- AFFIRMED.  
 REVERSED.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Reinstate Claimant's FAP application and apply Departmental policy in calculating Claimant's FAP benefits if otherwise eligible.

**NOTICE OF APPEAL:** A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of this Hearing Decision, or MAHS may order a rehearing or reconsideration on its own motion.

MAHS may grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
