**HEARING DECISION**

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on September 11, 2014, from Lansing, Michigan. Participants on behalf of Claimant included herself and her daughter [REDACTED] [REDACTED]. Participants on behalf of the Department of Human Services (Department) included Hearing Facilitator [REDACTED] and [REDACTED].

**ISSUE**

Did the Department properly deny Claimant's July 3, 2014, Food Assistance Program application for failure to provide required verifications?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On July 3, 2014, Claimant submitted an online Food Assistance Program application.
2. On July 3, 2014, a Verification Checklist (DHS-3503) and an Appointment Notice (DHS-170) were sent to Claimant. The Appointment Notice (DHS-170) scheduled a telephone interview at 11:00 am on July 14, 2014 and the verifications were due back on the same day, July 14, 2014.
3. On July 14, 2014, Claimant could not be reached by telephone for the interview. Claimant was sent a Notice of Missed Interview (DHS-254).
4. On July 16, 2014, Claimant submitted the required shelter verification.

5. On July 24, 2014, the Department called Claimant and the required interview was completed.
6. On July 28, 2014, the Department did not have verification of Claimant's savings and checking accounts. Claimant was sent a Notice of Case Action (DHS-1605) which stated her application was denied.
7. On August 8, 2014, Claimant submitted a hearing request.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

During this hearing Claimant testified that she submitted the bank statements along with the shelter verification. The Department's electronic documents inquiry report for Claimant shows the shelter verification but does not show any bank statements. It is noted that the report does show bank statements Claimant submitted in 2013.


The July 28, 2014, Notice of Case Action (DHS-1605) states that Claimant's Food Assistance Program application was denied. It also explains that the application will be re-registered and eligibility determined if the verifications are submitted within 60 days. Claimant has not submitted verification of her bank accounts to date.

Testimony and other evidence must be weighed and considered according to its reasonableness. *Gardiner v Courtright*, 165 Mich 54, 62; 130 NW 322 (1911); *Dep't of Community Health v Risch*, 274 Mich App 365, 372; 733 NW2d 403 (2007). Moreover, the weight and credibility of this evidence is generally for the fact-finder to determine. *Dep't of Community Health*, 274 Mich App at 372; *People v Terry*, 224 Mich App 447, 452; 569 NW2d 641 (1997). In evaluating the credibility and weight to be given the testimony of a witness, the fact-finder may consider the demeanor of the witness, the reasonableness of the witness's testimony, and the interest, if any, the witness may have in the outcome of the matter. *People v Wade*, 303 Mich 303 (1942), *cert den*, 318 US 783 (1943).

After considering all the evidence in the record, and the pertinent aspects, Claimant's testimony that she submitted the verifications on July 16, 2014 is not found credible. The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied Claimant's July 3, 2014, Food Assistance Program application for failure to provide required verifications.

**DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.

**NOTICE OF APPEAL:** A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of this Hearing Decision, or MAHS may order a rehearing or reconsideration on its own motion.

MAHS may grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
