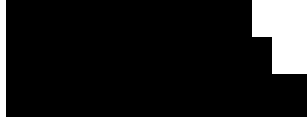

**HEARING DECISION**

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was held on January 7, 2015, from Lansing, Michigan. Participants on behalf of Claimant included herself. Participants on behalf of the Department of Human Services (Department) included ES [REDACTED] and AP Supervisor [REDACTED].

**ISSUE**

Did the Department properly determine Claimant's Food Assistance Program eligibility for December 2014?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Claimant was an ongoing recipient of Food Assistance Program benefits.
2. On November 3, 2014, Claimant was sent a Mid-Certification Contact Notice (DHS-2240-A) for her Medical Assistance and Food Assistance Program.
3. On November 10, 2014, Claimant was sent a Verification Checklist (DHS-3503) for her Food Assistance Program. The requested verifications were due by November 20, 2014.
4. On November 12, 2014, Claimant submitted a Mid-Certification Contact Notice (DHS-2240-A).

5. On November 13, 2014, Claimant's recertification was done and she was sent a Notice of Case Action (DHS-1605) showing her Food Assistance Program eligibility beginning December 1, 2014.
6. On November 19, 2014, Claimant submitted a hearing request. Claimant also submitted verification of her shelter expense.
7. On November 30, 2014, Claimant was sent a Redetermination (DHS-1010) for her Food Assistance Program.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

During this hearing the Department representatives testified that Claimant's increased rent expense was updated and it did not change her Food Assistance Program eligibility. The evidence submitted by the Department does include: a FAP excess shelter printout dated November 20, 2014 which shows the updated rent expense; a FAP gross income test dated November 20, 2014; and a FAP EDG summary dated November 20, 2014 showing that Claimant is eligible for \$16 per month of FAP for benefit period 12/01/2014.


Claimant testified that while the Department had updated the rent expense, the standard deduction was not included in the financial eligibility budget. As stated earlier, there is not a full Food Assistance Program financial eligibility budget for the November 13, 2014 eligibility determination or the updated eligibility determination. The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department failed to satisfy its burden of showing that it acted in accordance with Department policy when it determined Claimant's Food Assistance Program eligibility for December 2014.

### **DECISION AND ORDER**

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Re-determine Claimant's Food Assistance Program eligibility for December 2014.

**NOTICE OF APPEAL:** A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of this Hearing Decision, or MAHS **MAY** order a rehearing or reconsideration on its own motion.

MAHS **MAY** grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
