HEARING DECISION

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, a telephone hearing was conducted from Detroit, Michigan on Thursday, January 9, 2014. Claimant appeared, along with ██████████ ██████████ and testified. Participating on behalf of Department of Human Services (Department) was ██████████

ISSUE

Whether the Department properly calculated Claimant's Food Assistance Program (FAP) benefits as a result of the redetermination process?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. The Claimant was an ongoing FAP recipient in the monthly amount of \$82.00.
2. On September 23, 2013, the Department completed Claimant's FAP redetermination and certified FAP benefits in the amount of \$16.00. (Exhibit 1)
3. On October 3, 2013, the Department sent a Notice of Case Action to Claimant informing her of the new FAP allotment. (Exhibit 2)

4. On December 2, 2013, the Department received Claimant's written request for hearing. (Exhibit 3)

CONCLUSIONS OF LAW

Department policies are contained in the Bridges Administrative Manual ("BAM"), the Bridges Eligibility Manual ("BEM"), and the Bridges Reference Tables ("RFT").

The Food Assistance Program ("FAP"), formerly known as the Food Stamp program, is established by the Food Stamp Act of 1977, as amended, and is implemented by the federal regulations contained in Title 7 of the Code of Federal Regulations ("CFR"). The Department, formerly known as the Family Independence Agency, administers FAP pursuant to MCL 400.10, *et seq.*, and Mich Admin Code, Rules 400.3001 through 400.3015.

Clients must cooperate with the local office in determining initial and ongoing eligibility to include the completion of the necessary forms. BAM 105 (July 2013), p. 6. Verification means documentation or other evidence to establish the accuracy of the client's verbal or written statements. BAM 130 (July 2013), p. 1. Clients are allowed 10 calendar days (or other time limit specified in policy) to provide the requested verification(s). BAM 130, p. 5. For FAP purposes, benefits stop at the end of the benefit period **unless** a redetermination is completed **and** a new benefit period is certified. BAM 210 (July 2013), p. 2.

In this case, Claimant was an ongoing recipient of FAP benefits in the amount of \$82.00. Pursuant to policy, a redetermination was completed on September 23, 2013, to determine Claimant's ongoing FAP eligibility. The submitted verifications showed Claimant's daughter's earnings from employment had increased resulting in a decreased FAP benefit amount. During the hearing, the figures used in determining FAP eligibility were reviewed and found to be accurate. Claimant testified to some recent changes; however, these changes were not reported to the Department at the time the redetermination was completed. Ultimately, the Department established it acted in accordance with department policy when it completed Claimant's FAP redetermination and certified a new benefit period with a reduced FAP allotment of \$16.00.

DECISION AND ORDER

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, finds the Department established it acted in accordance with department policy when it completed Claimant's FAP redetermination and certified a new benefit period with a reduced FAP allotment of \$16.00.

Accordingly, it is ORDERED:

The Department's FAP determination is AFFIRMED.

NOTICE OF APPEAL: The claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely Request for Rehearing or Reconsideration was made, within 30 days of the receipt date of the Decision and Order of Reconsideration or Rehearing Decision.

Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request (60 days for FAP cases).

A Request for Rehearing or Reconsideration may be granted when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The Department, AHR or the claimant must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date the hearing decision is mailed.
