DECISION AND ORDER

This matter is before the undersigned Administrative Law Judge (ALJ) pursuant to MCL 400.9 and 42 CFR 431.200 *et seq.*, upon the Appellant's request for a hearing.

After due notice, a hearing was held on ██████████. The Appellant appeared without representation. ██████████, Appeals Review Officer, represented the Department of Community Health (Department). ██████████, Medicaid Utilization Analyst for DCH appeared as a witness.

ISSUE

Did the Department properly deny Appellant's prior authorization (PA) request for upper partial dentures?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. Appellant is a ██████-year-old Medicaid beneficiary, born ██████████. Appellant is a beneficiary of the SSI program.
2. On ██████████, Appellant's dentist (██████████) of ██████████ sought approval for upper and lower partial dentures. The PA states that the lpd would replace 5 teeth; the upd would replace 4 teeth. (Exhibit A.7)
3. On ██████████ the Department issued an approval letter for a lower partial denture.
4. On ██████████, the Department issued a separate notice letter to Appellant denying the upper partial denture request for the following reason: after consideration of placement of the approved lower denture, Appellant would have 8 or more posterior teeth in occlusion. (Exhibit A.5).

5. On ██████████, the Michigan Administrative Hearing System (MAHS) received Appellant's Request for Hearing.

CONCLUSIONS OF LAW

The Medical Assistance Program is established pursuant to Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). It is administered in accordance with state statute, the Social Welfare Act, the Administrative Code, and the State Plan under Title XIX of the Social Security Act Medical Assistance Program.

1.10 PRIOR AUTHORIZATION

Medicaid requires prior authorization (PA) to cover certain services before those services are rendered to the beneficiary. The purpose of PA is to review the medical need for certain services. . . .

Medicaid Provider Manual, (MPM)
Practitioner, April 1, 2013,¹ page 4.

Under the general policy instructions for Medicaid related dental services the MPM sets replacement schedules for denture repair and replacement:

GENERAL INSTRUCTIONS

Complete and partial dentures are benefits for all beneficiaries. All dentures require PA. Providers must assess the beneficiary's general oral health and provide a five-year prognosis for the prosthesis requested. An upper partial denture PA request must also include the prognosis of six sound teeth.

Complete or partial dentures are authorized:

- If there is one or more anterior teeth missing;
- If there are less than eight posterior teeth in occlusion (fixed bridges and dentures are to be considered occluding teeth); or
- Where an existing complete or partial denture cannot be made serviceable through repair, relining, adjustment, or duplicating (rebasing) procedures. If a partial denture can be made serviceable, the dentist should provide the needed restorations to maintain

use of the existing partial, extract teeth, add teeth to an existing partial, and remove hyperplastic tissue....

Reimbursement for a complete or partial denture includes all necessary adjustments, relines, repairs, and duplications within six months of insertion. This includes such services for an immediate upper denture when authorized.

If a complete or partial denture requires an adjustment, reline, repair, or duplication within six months of insertion, but the services were not provided until after six months of insertion, no additional reimbursement is allowed for these services.


Complete or partial dentures are not authorized when:

- A previous prosthesis has been provided within five years, whether or not the existing denture was obtained through Medicaid.
- An adjustment, reline, repair, or duplication will make them serviceable.
- Replacement of a complete or partial denture that has been lost or broken beyond repair is not a benefit within five years, whether or not the existing denture was obtained through Medicaid.

MPM, Dental, §6.6A, April 1, 2013, pp. 17, 18

At the hearing the Department witness testified that Appellant's request for lower partial dentures was approved, but her request for upper partial dentures was denied because with the placement of the lower partial dentures, Appellant will have 8 or more teeth in occlusion. The Department witness indicated that, per policy, Appellant did not, therefore, qualify for an upper partial denture.

On review, the Department's decision to deny the request for dentures was reached within policy. The Department approved the denture, the lpd that replaced the greatest amount of teeth, thereby giving Appellant the best option. 42 CFR 435.

The Administrative Law Judge, based on the above findings of fact and conclusions of law, decides that the Department properly denied the PA request for upper partial dentures was in compliance with Departmental policy and procedure.

IT IS THEREFORE ORDERED that:

The Department's decision is **AFFIRMED**.
