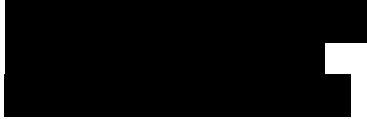

**HEARING DECISION**

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on Thursday, March 13, 2014, from Lansing, Michigan. Participants on behalf of Claimant included the Claimant. Participants on behalf of the Department of Human Services (Department) included , APSup and , APSup.

**ISSUE**

Did the Department properly  close Claimant's case for:

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Claimant  received:  FIP benefits.
2. The Department received a notice from the Office of Child Support (OCS) that the Claimant failed to cooperate and was in noncompliance with Child Support on November 12, 2013.
3. On November 13, 2013, the Department  closed Claimant's case due to failure to cooperate with the OCS to establish paternity.

4. On November 13, 2013, the Department sent Claimant/Claimant's Authorized Representative (AR) its decision.
5. On January 7, 2014, Claimant/Claimant's Authorized Hearing Representative (AHR) filed a hearing request, protesting the Department's actions.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), and Department of Human Services Reference Tables Manual (RFT).

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, PL 104-193, and 42 USC 601 to 679c. The Department (formerly known as the Family Independence Agency) administers FIP pursuant to MCL 400.10 and 400.57a and Mich Admin Code, R 400.3101 to .3131.

Additionally, the Department pended the Claimant's FIP case to close on November 13, 2013 because she failed to comply with OCS to establish [REDACTED] Department Exhibit 4. On November 13, 2013, the Department Caseworker sent the Claimant a notice that her FIP was pended to close on December 1, 2013 for failure to cooperate with establishing [REDACTED] or [REDACTED]. Department Exhibit 5-7.

During the hearing, the Claimant stated that she had cooperated as of November 22, 2013. However, the Claimant's cooperation did not occur until November 22, 2013, which gave the Department 10 days to reinstate the Claimant's case and issue benefits. As a result, the Claimant is only eligible for FIP benefits for only the second installment of December 2013 and a full issuance for January 2014. BEM 255.

The Department has met its burden that the Claimant was not in compliance with OCS, which resulted in her FIP case closing, but was reinstated after she complied with OCS on November 22, 2013. However, the Claimant's FIP case was reinstated within the 10 days of Department policy, but the Claimant did lose benefits for the first installment of December 2013.

The Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department  acted in accordance with Department policy when it when it closed the Claimant's FIP case due to non-compliance with Child Support.

**DECISION AND ORDER**

Accordingly, the Department's decision is  **AFFIRMED**.

**NOTICE OF APPEAL:** The claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely Request for Rehearing or Reconsideration was made, within 30 days of the receipt date of the Decision and Order of Reconsideration or Rehearing Decision.

Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request (60 days for FAP cases).

A Request for Rehearing or Reconsideration may be granted when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The Department, AHR or the claimant must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date the hearing decision is mailed.
