**HEARING DECISION**

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 42 CFR 431.200 to 431.250; and 45 CFR 205.10. After due notice, an in-person hearing was held on January 30, 2014, from Pontiac, Michigan. Participants on behalf of Claimant included Claimant ██████████. Participants on behalf of the Department of Human Services (Department) included ██████████.

The record was extended to allow additional relevant medical evidence to be submitted. Claimant waived timeliness. The additional medical evidence was received and submitted to the State Hearing Review Team (SHRT) for review prior to this decision being issued.

**ISSUE**

Whether the Department properly determined that Claimant is not "disabled" for purposes of the Medical Assistance (MA-P) and State Disability Assistance (SDA) programs?

**FINDINGS OF FACT**

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. On July 26, 2013, Claimant applied for MA-P, SDA and retro MA-P to April 2013.
2. On September 12, 2013, the Medical Review Team denied Claimant's request.

3. On September 20, 2013, Claimant submitted to the Department a request for hearing.
4. SHRT denied Claimant's request.
5. Claimant is 33 years old.
6. Claimant completed education through high school.
7. Claimant has employment experience (last worked 2013) in cooking and landscaping.
8. Claimant's limitations have lasted for 12 months or more.
9. Claimant suffers from necrotic hemorrhage, popliteal cyst on knee and large open draining wounds just above tailbone.
10. Claimant has significant limitations on physical activities involving sitting, standing, walking, bending, lifting, and stooping.
11. Claimant's Body Mass Index (BMI) based upon his height of 5'9" tall and weight of 312 pounds is 46.1.
12. On March 20, 2014, SHRT found Claimant disabled as of April 1, 2013, based upon newly submitted medical evidence.

### **CONCLUSIONS OF LAW**

MA-P is established by Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). The Department administers MA-P pursuant to MCL 400.10 *et seq.* and MCL 400.105. Department policies are found in the Bridges Administrative Manual (BAM), the Bridges Eligibility Manual (BEM) and the Bridges Reference Manual (RFT).

The SDA program, which provides financial assistance for disabled persons, is established by 2004 PA 344. The Department administers the SDA program pursuant to MCL 400.10 *et seq.* and MAC R 400.3151-400.3180. Department policies are found in BAM, BEM and RFT.

Additional medical records were received and submitted to SHRT for review. On March 20, 2014, SHRT found Claimant was disabled. Claimant was found disabled by SHRT based upon Claimant's application dated July 26, 2013, for MA and SDA, including requested retro months effective April 2013.


The Department has reversed the previous decision and will process the above application based upon the SHRT approval. The Department is required to initiate a

determination of Claimant's financial eligibility for the requested benefits, if not previously done, beginning April 2013.

**DECISION AND ORDER**

The Administrative Law Judge, based upon the above findings of fact and conclusions of law, decides that Claimant is medically disabled under the MA and SDA program as of April 2013.

Accordingly, the Department is hereby ORDERED to open an ongoing MA case for Claimant effective April 2013 and an SDA case in accordance with Department policy and supplement for any loss in benefits if otherwise eligible. A medical review shall be initiated in May 2015.

**NOTICE OF APPEAL:** The claimant may appeal the Decision and Order to Circuit Court within 30 days of the receipt of the Decision and Order or, if a timely Request for Rehearing or Reconsideration was made, within 30 days of the receipt date of the Decision and Order of Reconsideration or Rehearing Decision.

Michigan Administrative Hearing System (MAHS) may order a rehearing or reconsideration on either its own motion or at the request of a party within 30 days of the mailing date of this Decision and Order. MAHS will not order a rehearing or reconsideration on the Department's motion where the final decision cannot be implemented within 90 days of the filing of the original request (60 days for FAP cases).

A Request for Rehearing or Reconsideration may be granted when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The Department, AHR or the claimant must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date the hearing decision is mailed.
