DECISION AND ORDER

This matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 42 CFR 431.200 *et seq.*, upon the Appellant's request for a hearing.

After due notice, a hearing was held on ██████████. Appellant appeared and testified on her own behalf. ██████████, Appeals Review Officer, represented the Department. ██████████, Adult Services Worker ("ASW"), appeared as a witness for the Department.

ISSUE

Did the Department properly close the Appellant's Home Help Services ("HHS") case?

FINDINGS OF FACT

The Administrative Law Judge, based upon the competent, material and substantial evidence on the whole record, finds as material fact:

1. As of ██████████, the Appellant was receiving HHS. (Exhibit A, pp. 7, 10, 14)
2. On ██████████, the Department received a Medical Needs Form (54A) that was completed by the Appellant's primary care physician. The 54A indicated the Appellant did not need assistance with any personal care activities. (Exhibit A, p. 15; Testimony)
3. On ██████████, the Department conducted an annual assessment. (Exhibit A, pp. 9, 10; Testimony)
4. On ██████████, the Department sent the Appellant an Advance Negative Action Notice informing her that her HHS case was being closed based upon a lack of need. (Exhibit A, pp. 5-8; Testimony)
5. On ██████████, the Michigan Administrative Hearings System received the Appellant's request for hearing. (Exhibit A, p. 4)

CONCLUSIONS OF LAW

The Medical Assistance Program is established pursuant to Title XIX of the Social Security Act and is implemented by Title 42 of the Code of Federal Regulations (CFR). It is administered in accordance with state statute, the Social Welfare Act, the Administrative Code, and the State Plan under Title XIX of the Social Security Act Medical Assistance Program.

Home Help Services (HHS) are provided to enable functionally limited individuals to live independently and receive care in the least restrictive, preferred settings. These activities must be certified by a physician and may be provided by individuals or by private or public agencies.

Adult Services Manual (ASM) 101, 11-1-11, addresses HHS payments:

Payment Services Home Help

Home help services are non-specialized personal care service activities provided under the independent living services program to persons who meet eligibility requirements.

Home help services are provided to enable individuals with functional limitation(s), resulting from a medical or physical disability or cognitive impairment to live independently and receive care in the least restrictive, preferred settings.

Adult Services Manual (ASM) 105, 11-1-11, addresses HHS eligibility requirements:

Requirements

Home help eligibility requirements include all of the following:

- Medicaid eligibility.
- **Certification of medical need.**
- Need for service, based on a complete comprehensive assessment (DHS-324) indicating a functional limitation of level 3 or greater for activities of daily living (ADL).
- Appropriate Level of Care (LOC) status.

Adult Services Manual (ASM) 115, 11-1-11, addresses the Medical Needs Form:

The DHS-54A, Medical Needs form must be signed and dated by a medical professional certifying a medical need for personal care services.

The 54A that was completed by the Appellant's primary care physician. The 54A did not indicate a medical need for assistance with any personal care activities.

Although the Appellant indicated she was now seeing a new doctor, the form of record was completed by one of the Appellants treating physicians who at the time indicated there was no need for assistance with any personal care activities.

The Appellant's doctor did not certify a need for assistance with ADL's or IADL's, as required, on the Medical Needs Form. Accordingly, the closure of the Appellant's HHS case is upheld.

DECISION AND ORDER

The Administrative Law Judge, based on the above findings of fact and conclusions of law, finds that the Department properly closed the Appellant's HHS case based on the available information.

IT IS THEREFORE ORDERED THAT:

The Department's decision is AFFIRMED.
