### **HEARING DECISION**

# <u>ISSUE</u>

Did the Department properly determine the Claimant's monthly allotment of Food Assistance Program (FAP) benefits?

#### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. The Claimant is an ongoing Food Assistance Program (FAP) recipient.
- 2. - 3. On November 15, 2014, the Department notified the Claimant that she would receive a monthly allotment of Food Assistance Program (FAP) benefits effective December 1, 2014.
- 4. On November 24, 2014, the Department received the Claimant's request for a hearing protesting the amount of her Food Assistance Program (FAP) benefits.

# CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

All earned and unearned income available to the Claimant is countable. Earned income means income received from another person or organization or from self-employment for duties for duties that were performed for compensation or profit. Unearned income means all income that is not earned, including but not limited to funds received from the Family Independence Program (FIP), State Disability Assistance (SDA), Child Development and Care (CDC), Medicaid (MA), Social Security Benefits (RSDI/SSI), Veterans Administration (VA), Unemployment Compensation Benefits (UCB), Adult Medical Program (AMA), alimony, and child support payments. The amount counted may be more than the client actually receives because the gross amount is used prior to any deductions. Department of Human Services Bridges Eligibility Manual (BEM) 500 (July 1, 2014).

For all Food Assistance Program (FAP) groups that received the heat and utility standard on or before February 7, 2014, the heat and utility standard will remain in place for a period of five months after the month of their first redetermination or first reported case change occurring on or after May 1, 2014. In order to continue receiving the heat and utility standard beyond the expiration of the five month period, the Food Assistance Program (FAP) group must meet the requirements of the mandatory heat and utility standard section. Department of Human Services Bridges Eligibility Manual (BEM) 554 (October 1, 2014), p 15.

The Claimant is an ongoing Food Assistance Program (FAP) recipient as a group of one. On November 15, 2014, the Department conducted a review of her eligibility to receive continuing benefits and notified her that she would receive a monthly allotment of Food Assistance Program (FAP) benefits effective December 1, 2014.

The Claimant receives monthly Supplemental Security Income (SSI) in the gross monthly amount of and state Supplemental Security Income (SSP) in the gross monthly amount of which was determined by dividing her quarterly benefit payment by three. The Claimant's adjusted gross income of was determined by subtracting standard deduction and her allowable medical expense of from her total monthly income. The Claimant has a obligation for shelter expenses, which includes heat and utilities. The Claimant also received a credit because of her separate telephone service obligation. The Claimant's total countable housing expenses are less than 50% of her adjusted gross income; therefore she is not entitled

to an excess shelter deduction. Because of this, the Claimant's net income is the same as her adjusted gross income.

A group of one with a net income of \$ is entitled to a \$ monthly allotment of Food Assistance Program (FAP) benefits.

The Claimant argued that she had needs for additional Food Assistance Program (FAP) benefits due to her medical condition and need for a special diet.

The Department presented substantial evidence that it determined the Claimant's benefit amount in accordance with policy and that all allowable expenses and credits were applied.

The Claimant's request for additional benefits based on her needs is centered on dissatisfaction with the Department's current policy. Administrative Law Judges have no authority to overrule promulgated regulations or make exceptions to the Department policy set out in the program manuals. Administrative adjudication is an exercise of executive power rather than judicial power, and restricts the granting of equitable remedies. Michigan Mutual Liability Co. v Baker, 295 Mich 237; 294 NW 168 (1940).

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined the Claimant's monthly allotment of Food Assistance Program (FAP) benefits.

# **DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.

**NOTICE OF APPEAL**: A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of this Hearing Decision, or MAHS may order a rehearing or reconsideration on its own motion.

MAHS may grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
