HEARING DECISION

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10 After due notice, telephone hearing was held on January 14, 2015, from Lansing , Michigan. Participants on behalf of Claimant included terms and the Department of Human Services (Department) included terms.

<u>ISSUE</u>

Did the Department properly the amount of Food Assistance Program (FAP) benefits the Claimant is entitled to receive?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. The Claimant is an ongoing Food Assistance Program (FAP) recipient as a group of one
- 2. The Claimant received a total gross monthly income of \$749 in December of 2014.
- 3. The Claimant had a \$313 expense for shelter in December of 2014, and is obligated to pay for non-heat electricity and telephone expenses, but her shelter expenses includes heat.
- 4. On November 15, 2014, the Department notified the Claimant that it would reducer her monthly allotment of Food Assistance Program (FAP) benefits to \$67 effective December 1, 2014.

5. On December 5, 2014, the Department received the Claimant's request for a hearing protesting the amount of Food Assistance Program (FAP) benefits she is entitled to.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

All earned and unearned income available to the Claimant is countable. Earned income means income received from another person or organization or from self-employment for duties for duties that were performed for compensation or profit. Unearned income means all income that is not earned, including but not limited to funds received from the Family Independence Program (FIP), State Disability Assistance (SDA), Child Development and Care (CDC), Medicaid (MA), Social Security Benefits (RSDI/SSI), Veterans Administration (VA), Unemployment Compensation Benefits (UCB), Adult Medical Program (AMA), alimony, and child support payments. The amount counted may be more than the client actually receives because the gross amount is used prior to any deductions. Department of Human Services Bridges Eligibility Manual (BEM) 500 (July 1, 2014).

For all Food Assistance Program (FAP) groups that received the heat and utility standard on or before February 7, 2014, the heat and utility standard will remain in place for a period of five months after the month of their first redetermination or first reported case change occurring on or after May 1, 2014. In order to continue receiving the heat and utility standard beyond the expiration of the five month period, the Food Assistance Program (FAP) group must meet the requirements of the mandatory heat and utility standard section. Department of Human Services Bridges Eligibility Manual (BEM) 554 (October 1, 2014), p 15.

The Claimant was an ongoing Food Assistance Program (FAP) recipient when the Department examined her eligibility to receive continuing benefits. The Claimant received a total gross monthly income of \$749 in December of 2014, an amount that she did not dispute during the hearing. The Claimant's adjusted gross income of \$595 was determined by subtracting the \$174 standard deduction from her total monthly income. No evidence was presented during the hearing that the Claimant reported any eligible medical or child care expenses to the Department. The Claimant's excess

shelter deduction of \$174 was determined by adding her \$313 monthly shelter expenses to the \$124 standard non-heat electricity deduction and the \$34 standard telephone deduction, then subtracting 50% of her adjusted gross income.

The Claimant's net income of \$421 was determined by subtracting her excess shelter deduction from her adjusted gross income. A group of one with a net income of \$421 is entitled to a \$67 monthly allotment of Food Assistance Program (FAP) benefits.

The Claimant testified that she did not understand why the Department reduced her Food Assistance Program (FAP) benefits despite her fixed income and expenses.

After reviewing the evidence, this Administrative Law Judge finds that the Department presented substantial evidence showing that it properly applied the Claimant's expenses allowable by policy against her income when determining the amount of Food Assistance Program (FAP) that she is eligible for.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined the Claimant's monthly allotment of Food Assistance Program (FAP) benefits.

DECISION AND ORDER

Accordingly, the Department's decision is AFFIRMED.

NOTICE OF APPEAL: A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of

this Hearing Decision, or MAHS may order a rehearing or reconsideration on its own motion.

MAHS may grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
