HEARING DECISION

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on March 03, 2015, from Lansing, Michigan. Participants on behalf of Claimant included her adult daughter [REDACTED] as the Claimant's authorized hearing representative. Participants on behalf of the Department included [REDACTED].

ISSUE

Did the Department properly reduce the Claimant's monthly allotment of Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. The Claimant is an ongoing Food Assistance Program (FAP) recipient.
2. The Claimant receives monthly unearned income in the gross monthly amount of \$755.
3. The Claimant has monthly housing expenses of \$ [REDACTED] that includes utilities but not telephone expenses.
4. On December 5, 2014, the Department notified the Claimant that it would reduce her allotment of Food Assistance Program (FAP) benefits to \$ [REDACTED] effective January 1, 2015.
5. On January 20, 2014, the Department received the Claimant's request for a hearing protesting the amount of her Food Assistance Program (FAP) benefits she is entitled to.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Human Services Bridges Administrative Manual (BAM), Department of Human Services Bridges Eligibility Manual (BEM), Department of Human Services Reference Tables Manual (RFT), and Department of Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food Stamp Act of 1977, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Family Independence Agency) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.

For all Food Assistance Program (FAP) groups that received the heat and utility standard on or before February 7, 2014, the heat and utility standard will remain in place for a period of five months after the month of their first redetermination or first reported case change occurring on or after May 1, 2014. In order to continue receiving the heat and utility standard beyond the expiration of the five month period, the Food Assistance Program (FAP) group must meet the requirements of the mandatory heat and utility standard section. Department of Human Services Bridges Eligibility Manual (BEM) 554 (October 1, 2014), p 15.


The Claimant is an ongoing Food Assistance Program (FAP) recipient as a group of one. The Claimant receives a monthly gross income of \$ [REDACTED] an amount that was not disputed by her representative at the hearing. The Claimant's adjusted gross income of \$ [REDACTED] was determined by reducing her total gross income by the standard \$ [REDACTED] deduction. The Claimant has monthly housing expenses of \$ [REDACTED] and this includes heat and utility expenses. Because she does not have an obligation for heat and utilities, the Department removed the \$ [REDACTED] heat and utility deduction that had been previously included in her eligibility determination. The Claimant is not entitled to an excess shelter deduction because 50% of her adjusted gross income is greater than her monthly housing costs. Therefore, the Claimant's net monthly income is equal to her adjusted gross income.

A group of one with a net income of \$ [REDACTED] is entitled to a \$ [REDACTED] monthly allotment of Food Assistance Program (FAP) benefits.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined the Claimant's eligibility for the Food Assistance Program (FAP).

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.

NOTICE OF APPEAL: A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date.

A party may request a rehearing or reconsideration of this Hearing Decision from the Michigan Administrative Hearing System (MAHS) within 30 days of the mailing date of this Hearing Decision, or MAHS may order a rehearing or reconsideration on its own motion.

MAHS may grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
