HEARING DECISION

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, an in person hearing was held on April 15, 2015, from Ypsilanti, Michigan. Participants on behalf of Claimant included Claimant; Claimant's wife, Claimant's daughter, Participants on behalf of the Department of Health and Human Services (Department) included and Language interpreter.

ISSUE

Did the Department properly close Claimant's Family Independence Program (FIP) case for failing to participate with the PATH program?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On December 15, 2014, household member was sent to PATH after she became eligible for FIP.
- 2. On January 9, 2015, a noncompliance letter was sent to Claimant with a January 15, 2015, triage meeting scheduled.
- 3. On January 9, 2015, Notice of Case Action was sent to Claimant informing that the case would close on February 1, 2015.

- 4. On January 15, 2015, the case was reinstated due to the Hearing Request and a Medical Needs Form was sent out.
- 5. On January 20, 2015, the Medical Needs Form was returned showing was needed to provide care for her husband.
- 6. The Medical Needs Form dated January 16, 2015, states that for 8-12 hours a day someone is needed in the home to provide care.
- 7. Claimant previously provided a Medical Needs Form showing that needed his wife to provide care for him.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Pub. L. No. 104-193, and 42 USC 601 to 679c. The Department (formerly known as the Department of Human Services) administers FIP pursuant to 45 CFR 233-260, MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3101-.3131.

Illness or Injury

The client has a debilitating illness or injury, or a spouse or child's illness or injury requires in-home care by the client. BEM 233A

In this case, provided a statement from her husband's treating physician that she is needed to provide home care for her husband who is wheelchair bound. Department policy specifically states that providing home care for a disabled spouse is grounds for good cause for failing to meet PATH requirements. BEM 233A Claimant had good cause for not participating with the PATH program.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not act in accordance with Department policy when it closed Claimant's FIP case.

DECISION AND ORDER

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

- 1. Reinstate Claimant's FIP benefits going back to the date of closure.
- 2. Delete the finding of non-compliance.
- 3. Issue Claimant any supplement for any missed benefits.

NOTICE OF APPEAL: A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date. A copy of the claim or application for appeal must be filed with the Michigan Administrative Hearing System (MAHS).

A party may request a rehearing or reconsideration of this Hearing Decision from MAHS within 30 days of the mailing date of this Hearing Decision, or MAHS <u>MAY</u> order a rehearing or reconsideration on its own motion. MAHS <u>MAY</u> grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
