HEARING DECISION

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on November 12, 2015, from Lansing, Michigan. Participants on behalf of Claimant included his daughter and authorized hearing representative. Participants on behalf of the Department of Health and Human Services (Department) included Assistance Payments Worker and Family Independence Manager.

ISSUE

Did the Department properly close Claimant's Food Assistance Program (FAP) on September 12, 2015 for failure to return verifications which were due on May 4, 2015 and submitted on May 7, 2015?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- Claimant was an ongoing recipient of Food Assistance Program (FAP) benefits.
- 2. On April 24, 2015, Claimant was sent a Verification Checklist (DHHS-3503). The requested verifications were due on May 4, 2015.
- On May 7, 2015, Claimant submitted the requested verifications.

- 4. On September 12, 2015, Claimant was sent a Notice of Case Action (DHHS-1605) which stated his Food Assistance Program (FAP) would close beginning October 1, 2015.
- 5. On September 23, 2015, Claimant submitted a hearing request.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

During this hearing the Department representatives were not sure why the September 12, 2015 Notice of Case Action (DHHS-1605) was generated by BRIDGES. The Department representatives found no evidence that any notice had been sent previously regarding the verifications due in May 2015. Bridges Administration Manual (BAM) XXX 220 Case Actions at pages 12 & 13 provides guidance for deleting a negative action when a requirement is met before a negative action effective date. In this case the requirement was met before a negative action notice was ever sent.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not act in accordance with Department policy when it closed Claimant's Food Assistance Program (FAP) on September 12, 2015 for failure to return verifications which were due on May 4, 2015 and submitted on May 7, 2015.

DECISION AND ORDER

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

- 1. Reinstate Claimant's Food Assistance Program (FAP) and process in accordance with Department policy.
- 2. Supplement Claimant any Food Assistance Program (FAP) benefits he was otherwise eligible for but did not receive due to this incorrect action.

NOTICE OF APPEAL: A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date. A copy of the claim or application for appeal must be filed with the Michigan Administrative Hearing System (MAHS).

A party may request a rehearing or reconsideration of this Hearing Decision from MAHS within 30 days of the mailing date of this Hearing Decision, or MAHS <u>MAY</u> order a rehearing or reconsideration on its own motion. MAHS <u>MAY</u> grant a party's Request for Rehearing or Reconsideration when one of the following exists:

 Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;

- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
