**ORDER OF DISMISSAL PURSUANT TO  
PETITIONER'S WITHDRAWAL OF REQUEST FOR HEARING**

Upon the request for a hearing by the Department of Health and Human Services (Department), this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16 and 45 CFR 235.110; and with Mich Admin Code, R 400.3130 and 400.3178. After due notice, a telephone hearing was held on July 1, 2015, from Lansing, Michigan. The Department was represented by [REDACTED], Regulation Agent of the Office of Inspector General (OIG).

Respondent did not appear at the hearing and it was held in Respondent's absence pursuant to 7 CFR 273.16(e), Mich Admin Code R 400.3130(5), or Mich Admin Code R 400.3178(5).

Subsequent to the scheduling of the hearing and prior to the hearing date, the Notice of Disqualification Hearing that was mailed to Respondent at the last known address, and that constituted due notice, was returned to the Michigan Administrative Hearing System (MAHS) by the United States Postal Service as undeliverable.

During the hearing proceedings, the OIG Regulation Agent testified that the Department has received new information regarding Respondent's address indicating she may have moved back to a prior address. The OIG Regulation Agent withdrew the Request for Hearing so that it could be re-filed with any updated address information.

Accordingly, the request for a disqualification hearing is **DISMISSED**.
