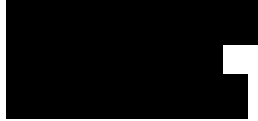

**HEARING DECISION**

Following Claimant's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on July 14, 2015, from Lansing, Michigan. Participants on behalf of Claimant included his authorized hearing representative from [REDACTED]. Participants on behalf of the Department of Health and Human Services (Department) included Assistance Payment Worker [REDACTED] and AP Supervisor [REDACTED].

**ISSUE**

Did the Department properly deny Claimant's August 4, 2014, Medical Assistance (MA) application?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On August 4, 2014, [REDACTED] submitted an MA application including a request for retroactive coverage for July 2014.
2. On February 19, 2015, a Health Care Coverage Determination Notice (DHS-1606) was issued by the Department, which stated Claimant was not eligible from October 1, 2014, ongoing.
3. On May 11, 2015, [REDACTED] submitted a hearing request.
4. On May 26, 2015, a Benefit Notice (DHS-176) was issued by the Department, which stated Claimant was not eligible for MA from August 1, 2014, through January 31, 2015, but was eligible for HMP from February 1, 2015.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Even with the May 26, 2015, Benefit Notice (DHS-176) issued following this hearing request, the Department has not addressed the month of July 2014. The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department failed to satisfy its burden of showing that it acted in accordance with Department policy when it denied Claimant's August 4, 2014, MA application.


### **DECISION AND ORDER**

Accordingly, the Department's decision **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Re-register Claimant's August 4, 2014, MA and retroactive MA application in the county of his residence. Claimant resides in [REDACTED]. The application was originally processed by one of the Self-Service Processing Centers (SSPC). When the SSPC closed, the case worker who processed the application transferred to [REDACTED] County. This hearing was conducted at [REDACTED] County. For the convenience of the Claimant, transfer the application to his county of residence.
2. Process the application in accordance with Department policy.

3. Issue current notice of the Medical Assistance eligibility determination.

**NOTICE OF APPEAL**: A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date. A copy of the claim or application for appeal must be filed with the Michigan Administrative Hearing System (MAHS).

A party may request a rehearing or reconsideration of this Hearing Decision from MAHS within 30 days of the mailing date of this Hearing Decision, or MAHS **MAY** order a rehearing or reconsideration on its own motion. MAHS **MAY** grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.
