**HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on November 17, 2015, from Lansing, Michigan. The Petitioner was represented by her authorized representative, [REDACTED], from [REDACTED]. The Department of Health and Human Services (Department) was represented by [REDACTED], Hearing Facilitator.

**ISSUE**

Did the Department properly determine the Claimant's eligibility for Medical Assistance (MA)?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On April 29, 2015, the Claimant applied for MA for her daughter.
2. On April 29, 2015, the Claimant's daughter application for MA was denied due to excess income and a referral was sent for MiCHILD.
3. On May 5, 2015, [REDACTED] filed an application on behalf of the Claimant's daughter.
4. On May 5, 2015, the Claimant's daughter application for MA was denied and a referral was sent for MiCHILD.
5. On September 4, 2015, the Department received a hearing request from [REDACTED] contesting the Department's negative action.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, the Claimant applied for MA for her daughter on April 29, 2015. On April 29, 2015, the Claimant's daughter application for MA was denied due to excess income and a referral was sent for MiCHILD. On May 5, 2015, [REDACTED] filed an application on behalf of the Claimant's daughter. On May 5, 2015, the Claimant's daughter application for MA was denied and a referral was sent for MiCHILD.

During the hearing, the Authorized Representative stated that they wanted the child to be considered for Group 2 MA with a spend-down. However, according to Department's policy the Claimant's daughter is only eligible for MiChild. The earliest referral to MiCHILD was April 29, 2015. On November 17, 2015, the Department Caseworker received clarification that since the referral was received after April 23, 2015 that the earliest coverage could be put on was June 1, 2015. BEM 131, 500, and 501. MSA 13-35. BAM 105, 110, 115, 130, 220, and 600.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied the Claimant's daughter application due to excess income and referred the Claimant's daughter to the MiCHILD program on April 29, 2015 based on a MA application dated April 29, 2015.

**DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.

**NOTICE OF APPEAL:** A party may appeal this Hearing Decision in the circuit court in the county in which he/she resides, or the circuit court in Ingham County, within 30 days of the receipt date. A copy of the claim or application for appeal must be filed with the Michigan Administrative Hearing System (MAHS).

A party may request a rehearing or reconsideration of this Hearing Decision from MAHS within 30 days of the mailing date of this Hearing Decision, or MAHS **MAY** order a rehearing or reconsideration on its own motion. MAHS **MAY** grant a party's Request for Rehearing or Reconsideration when one of the following exists:

- Newly discovered evidence that existed at the time of the original hearing that could affect the outcome of the original hearing decision;
- Misapplication of manual policy or law in the hearing decision which led to a wrong conclusion;
- Typographical, mathematical or other obvious error in the hearing decision that affects the rights of the client;
- Failure of the ALJ to address in the hearing decision relevant issues raised in the hearing request.

The party requesting a rehearing or reconsideration must specify all reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration. A request must be *received* in MAHS within 30 days of the date this Hearing Decision is mailed.


