**ORDER OF DISMISSAL PURSUANT TO  
WITHDRAWAL OF HEARING REQUEST AT HEARING**

This matter is before the Michigan Administrative Hearing System upon Petitioner's request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing was commenced on, [REDACTED] [REDACTED] from Detroit, Michigan. The Petitioner was represented by [REDACTED], the Petitioner's Authorized Hearing Representative (AHR). The Petitioner's AHR spoke English. The Petitioner did not appear. The Department of Health and Human Services (Department) was represented by [REDACTED], Eligibility Specialist.

The hearing was requested to dispute the Department's action taken with respect to the Petitioner's August 2014 application for Medical Assistance (MA) and her eligibility for full medical coverage rather than Emergency Services Only (ESO) MA program benefits. Shortly after commencement of the hearing, the Petitioner's AHR testified that he now understood the actions taken by the Department. The Department had corrected the Petitioner's coverage as she had been a permanent resident of the United States for five (5) years or more and did not wish to proceed with the hearing. The Request for Hearing was withdrawn. The Department agreed to the dismissal of the hearing request.

Pursuant to the withdrawal of the hearing request filed in this matter, the Request for Hearing is, hereby, **DISMISSED**.
