## **HEARING DECISION**

Pursuant to a September 8, 2014, federal lawsuit, the Department of Health and Human Services (Department) issued notices to Medicaid applicants who were potentially denied full Medicaid coverage based on immigration status between January 2014 and May 2015. The notice included information about how to request a hearing. Petitioner filed a request for a hearing; and accordingly, this matter is before the undersigned Administrative Law Judge pursuant to Michigan Administrative Hearing Rules (R 792.10101 – R 792.11903) and the Administrative Procedures Act, 1969 PA 306, as amended, MCL 24.201 *et seq.* 

After due notice, a three-way telephone hearing was held on March 7, 2016, from Detroit, Michigan. The Petitioner, **and the second seco** 

## <u>ISSUE</u>

Did the Department properly determine Petitioner's immigration status or citizenship when determining Medicaid (MA) eligibility?

## FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On Petitioner applied for MA benefits. See Exhibit A, pp. 5-13.
- 2. On the date of MA application, Petitioner was not a United States citizen. See Exhibit A, p. 6. However, she was eligible for full MA coverage because she had

resided in the U.S. for five or more years. See Exhibit A, p. 3 (Petitioner's permanent resident card).

- 3. On an unspecified date, Petitioner received Emergency Services Only (ESO) MA coverage; however, the Department updated the benefit periods that previously had ESO coverage and provided Petitioner with full-coverage MA from March 2015, ongoing. See Exhibit A, pp. 1 and 14-15 (Medicaid Eligibility).
- 4. On , Petitioner's AHR requested a hearing. See Exhibit A, p. 2.
- 5. On Determination Notice notifying her that she is eligible for full MA coverage effective , ongoing. See Exhibit A, p. 16.

# CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), Department of Health and Human Services Modified Adjusted Gross Income (MAGI) Related Eligibility Manual (MREM), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

## Preliminary matter

On the AHR was present for her own hearing as well as three additional hearings scheduled at the same time in which she acted as their Authorized Hearing Representative (AHR). The undersigned consolidated all four hearings scheduled and held one administrative hearing. However, the undersigned issued separate hearing decisions for each case. A separate decision was issued regarding (AHR), (Reg. No. 15-022662), (Reg. No. 15-022661), and (Reg. No. 15-023177).

## ESO coverage

In this case, Petitioner's AHR requested a hearing disputing the MA coverage. See Exhibit A, p. 2. It should also be noted that the undersigned's jurisdiction is only to review whether the Department denied Petitioner's full MA coverage between January 2014 to May 2015, in accordance with federal and state laws and policies.

To be eligible for full coverage MA, a person must be a U.S. citizen or an alien admitted to the U.S. under a specific immigration status. BEM 225 (January 2014; July 2014; October 2014; and October 2015), p. 2. An individual who is a permanent resident alien with a class code on the permanent residency card other than RE, AM or AS is eligible only for ESO MA coverage for the first five years in the U.S. unless the alien is a qualified military alien or the spouse or dependent child of a qualified military alien. BEM 225, pp. 7-8, 30; MREM, § 3.6. A qualified military alien is a qualified alien on active duty in, or veteran honorably discharged from, the U.S. Armed Forces. BEM 225, p. 5; MREM, § 3.6. A person who does not meet an acceptable alien status, including undocumented aliens and non-immigrants who have stayed beyond the period authorized by the U.S. Citizenship and Immigration Services, are eligible only for ESO MA coverage. BEM 225, p. 2.

In the present case, Petitioner was not a United States citizen. See Exhibit A, p. 6. However, she was eligible for full coverage MA from the date of application, ongoing, because she had been a permanent resident for five or more years (resident since ). See Exhibit A, p. 3 (Petitioner's permanent resident card) and BEM 225, pp. 7-8, 30; MREM, § 3.6. Moreover, the Department updated all benefit periods that previously had ESO coverage and provided Petitioner with full MA coverage from March 2015, ongoing. See Exhibit A, pp. 14-15. The evidence established that Petitioner received full coverage MA from March 2015, ongoing, and that she did not have any active MA coverage before March 2015. As such, the Department properly determined that Petitioner was eligible for full-coverage MA.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did properly determine Petitioner's immigration status or citizenship when determining MA eligibility.

# **DECISION AND ORDER**

Accordingly, the Department's determination about MA eligibility based on immigration status is **AFFIRMED**.
