### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on March 8, 2016, from Lansing, Michigan. Petitioner was represented by himself. The Department was represented by Assistance Payments Worker and Assistance Payments Supervisor Department employee provided Arabic language interpreter services.

### ISSUE

Did the Department properly determine Petitioner's Food Assistance Program (FAP) eligibility?

# FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. Petitioner was an ongoing recipient of Food Assistance Program (FAP) benefits.
- On October 22, 2015, the Department updated Petitioner's Food Assistance Program (FAP) financial eligibility budget and sent him a Notice of Case Action (DHS-1605).
- 3. On January 28, 2016, petitioner submitted a hearing request.

# CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

While Petitioner's hearing request was not timely for review of the October 22, 2015 Food Assistance Program (FAP) eligibility determination, the amount of his Food Assistance Program (FAP) allotment at the time of the hearing request will be reviewed.

Petitioner saw a reduction in his Food Assistance Program (FAP) allotment due to the October 22, 2015, updated of his Food Assistance Program (FAP) financial eligibility budget. The reduction was caused by Petitioner's report that his heat and utilities are included in his rent. During this hearing, Petitioner testified that his heat and utilities are included in his rent. During this hearing Claimant's current income and expenses were verified. The Food Assistance Program (FAP) budget was reviewed and the Department properly computed the claimant's net income, expenses and eligibility.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it determined Petitioner's Food Assistance Program (FAP) eligibility.

# **DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.
