HEARING DECISION

Pursuant to a September 8, 2014, federal lawsuit, the Department of Health and Human Services (Department) issued notices to Medicaid applicants who were potentially denied full Medicaid coverage based on immigration status between January 2014 and May 2015. The notice included information about how to request a hearing. Petitioner filed a request for a hearing; and accordingly, this matter is before the undersigned Administrative Law Judge pursuant to Michigan Administrative Hearing Rules (R 792.10101 – R 792.11903) and the Administrative Procedures Act, 1969 PA 306, as amended, MCL 24.201 *et seq.*

After due notice, a telephone hearing was held on April 12, 2016, from Lansing, Michigan. The Petitioner appeared on her own behalf. The Department was represented by Assistance Payments Worker **Example 1**. **Example 1** served as translator during the hearing.

<u>ISSUE</u>

Did the Department properly determine Petitioner's immigration status or citizenship when determining Medicaid (MA) eligibility?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On December 7, 2014 Petitioner applied for MA or had a redetermination of current MA benefits.
- 2. On the date of MA application or redetermination, Petitioner was not a United States citizen.

- 3. Beginning December 1, 2014, Petitioner's application was approved for Emergency Services Only (ESO) MA coverage.
- 4. In August 2015, the Department issued a notice to the Petitioner indicating she might have been denied full MA coverage based on immigration status between January 2014 and May 2015.
- 5. On August 27, 2015, Petitioner requested a hearing.
- 6. On March 23, 2016, the Department provided Petitioner with a Benefit Notice (Exhibit 1 Pages 20-21) noting she was being provided full coverage effective December 1, 2014 through January 31, 2016.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), Department of Health and Human Services Modified Adjusted Gross Income (MAGI) Related Eligibility Manual (MREM), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, Petitioner requested a hearing disputing the denial of full MA coverage.

To be eligible for full MA coverage a person must be a U.S. citizen or an alien admitted to the U.S. under a specific immigration status. BEM 225 (1/1/14), p. 2. At time of application or redetermination, Petitioner or Petitioner's family member status was Permanent Resident. (Exhibit 1 Page 19.)

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not properly determine Petitioner's immigration status or citizenship when determining MA eligibility. However, that error was resolved prior to the hearing.

Petitioner was to have submitted a Redetermination in March 2016. According to the Department, the Redetermination was not received and therefore Petitioner was advised that she needed to reapply if she wanted to have her MA reinstated. That is not an issue to be adjudicated at this time.
