### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on April 19, 2016, from Lansing, Michigan. Participants on behalf of Petitioner included her mother (Hearing Facilitator) represented the Department of Health and Human Services (Department).

# **ISSUE**

Did the Department of Health and Human Services (Department) properly deny Medical Assistance (MA)?

### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On January 20, 2016, the Department received the Petitioner's Medical Assistance (MA) application. Exhibit A.
- 2. On February 8, 2016, the Department notified the Petitioner (d.o.b. 12/20/14) that her mother and sister were not eligible for Medical Assistance (MA). Exhibit B.
- 3. On February 23, 2016, the Department received the Petitioner's request for a hearing.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Persons may qualify under more than one MA category. Federal law gives them the right to the most beneficial category. The most beneficial category is the one that results in eligibility or the least amount of excess income. Department of Health and Human Services Bridges Eligibility Manual (BEM) 105 (January 1, 2016), p 2.

On January 20, 2016, the Department received the Petitioner's application for MA benefits. The Petitioner, a one year old child, was registered as the benefit grantee but her mother and sister were denied MA benefits.

The Department's representative testified that it was necessary to close this application for benefits to process the group's eligibility for MA benefits under the mother's benefit case number.

The benefit group's eligibility for MA benefits has been contested in another hearing, which resulted in an order to the Department to redetermine MA eligibility for the group, including the Petitioner in this case. Therefore, this hearing request is a moot point pending the determination of eligibility on the mother's case. The Department has been ordered to redetermine eligibility for MA benefits as of November 1, 2015, and if benefits are denied as a result of that eligibility determination, the Petitioner may appeal the denial of MA benefits with the timely submission of another request for a hearing.

The members of the Petitioner's MA benefit group are eligible for MA benefits in one category. Since the January 20, 2016, application for MA benefits is duplicative, the Department's closure of that application was a proper application of policy.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied Medical Assistance (MA).

# **DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.
