HEARING DECISION

Upon the request for a hearing by the Department of Health and Human Services (Department), this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9, and in accordance with Titles 7, 42 and 45 of the Code of Federal Regulation (CFR), particularly 7 CFR 273.16 and 45 CFR 235.110; and with Mich Admin Code, R 400.3130 and 400.3178. After due notice, a telephone hearing was held on April 14, 2016, from Lansing, Michigan. The Department was represented by Recoupment Specialist Linda Coon, Regulation Agent of the Office of Inspector General (OIG). Respondent, and her husband [REDACTED], personally appeared and testified.

ISSUE

Did Respondent receive an over-issuance of Food Assistance Program (FAP) benefits?

FINDINGS OF FACT

The Administrative Law Judge, based on competent, material, and substantial evidence on the whole record, finds as material fact:

1. The Department submitted Exhibit A, pages 1-35 with no objection. (Dept. Ex. A, pp 1-35).
2. Respondent was a recipient of FAP benefits from the Department at all times relevant to this hearing.
3. The Department alleges Respondent received a FAP overissuance during the period of May 1, 2014, through July 31, 2014, due to Respondent's error.

4. The Department alleges that Respondent received a [REDACTED] overissuance that is still due and owing to the Department.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), and Department of Health and Human Services Reference Tables Manual (RFT).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001 to .3015.


Respondent's husband testified that when he completed the FAP application on May 7, 2014, Respondent had not started working at the [REDACTED]. However, a review of the Wage Verification from the [REDACTED] indicates Respondent's start date was on April 1, 2014. (Dept. Exh. A, p 24).

Therefore, the Administrative Law Judge, based upon the above Findings of Fact and Conclusions of Law, finds that the Department did establish a FAP benefit overissuance to Respondent totaling [REDACTED].

DECISION AND ORDER

Accordingly, the Department is AFFIRMED.

The Department is ORDERED to initiate collection procedures for a [REDACTED] overissuance in accordance with Department policy.
