HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, an in-person hearing was held on March 17, 2016, in Flint, Michigan. Petitioner and his wife personally appeared and testified. Petitioner was represented by ██████████. The Department of Health and Human Services (Department) was represented by Hearing Facilitator ██████████

ISSUE

Did the Department properly determine Petitioner was not eligible for the Medicare Savings Program because it was in a previous year?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On September 28, 2015, Petitioner applied for the Medicare Savings Program. (Dept Exh. A, pp 7-32).
2. On January 6, 2016, the Department issued Petitioner a Health Care Coverage Determination Notice approving Petitioner for full coverage under the Medicare Savings Program beginning January 1, 2016. The Notice informed Petitioner that he was not eligible for the Medicare Savings Program for October 1, 2015 through December 1, 2015 because it was in a previous year. (Dept Exh. A, pp 41-46).
3. On February 12, 2016, Petitioner's Authorized Hearing Representative submitted a request for a hearing contesting the Department's actions.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Medicare Savings Programs are SSI-related MA categories. BEM 165, p 1 (1/1/2015). Additional Low-Income Medicare Beneficiaries (ALMB) is one of three categories making up the Medicare Savings Programs. BEM 165, p 1. If a client's net income is over 120% of the poverty level, but not over 135% of the poverty level, the client is eligible for ALMB. BEM 165, p 1. All eligibility factors must be met in the calendar month being tested. BEM 165, p 1. ALMB pays Medicare Part B premiums provided funding is available. BEM 165, p 2.

In this case, the Department acknowledged during the hearing that Petitioner met the requirements of the Medicare Savings Program and in fact, had been eligible for the Medicare Savings Program since July, 2011 due to his receipt of Retirement, Survivors, Disability Income benefits.


Therefore, the Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, finds that the Department did not act in accordance with Department policy when it determined Petitioner was only eligible for the Medicare Savings Program beginning January 1, 2016.

DECISION AND ORDER

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Redetermine Petitioner's Medicare Savings Program eligibility beginning July, 2011.
2. Issue Petitioner any retroactive benefits he may otherwise be eligible to receive.
