**HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a 3 way telephone hearing was held on April 26, 2016, from Lansing, Michigan. The Petitioner was represented by [REDACTED] [REDACTED] Authorized Representative. The Department of Health and Human Services (Department) was represented by [REDACTED] [REDACTED] AP Supervisor and [REDACTED] [REDACTED] AP Worker.

**ISSUE**

Did the Department properly deny Petitioner's application for Medicaid for failing to return verifications?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On December 24, 2015, Petitioner applied for Medicaid benefits.
2. On December 30, 2015, a verification checklist was sent to Petitioner requesting "current statement from bank or financial institution" with a January 11, 2016 deadline.
3. On January 25, 2016, Petitioner submitted current credit union information by fax.
4. On February 8, 2016, the Department denied Petitioner's application for failing to return verifications.
5. On February 29, 2016, Petitioner requested hearing disputing the denial.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, Petitioner provided current credit union account information on January 25, 2016, prior to the Department denial for failing to return verifications on February 8, 2016. The Department acknowledged at hearing that they were in receipt of all necessary asset verifications. Since the Department was in receipt of all necessary information prior to the application being denied then the application should have been processed.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department did not act in accordance with Department policy when it denied Petitioner's application for Medicaid for failing to return verifications.

### **DECISION AND ORDER**

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Reinstate and reprocess Petitioner's application for Medicaid going back to the date of application.
2. Award Medicaid benefits if Petitioner is found otherwise eligible.
