## ORDER OF DISMISSAL PURSUANT TO WITHDRAWAL OF HEARING REQUEST AT HEARING

This matter is before the Michigan Administrative Hearing System upon Petitioner's request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing was commenced on from Detroit, Michigan. The Petitioner was represented by herself. The Department of Health and Human Services (Department) was represented by Eligibility Specialist. A translator, appeared to assist the Petitioner.

The hearing was requested to dispute the Department's action taken with respect to the medical assistance program benefits regarding Emergency Services Only (ESO) coverage program benefits. Shortly after commencement of the hearing, Petitioner testified that she now understood the actions taken by the Department, that they had corrected her case to full coverage based upon her permanent resident status, and did not wish to proceed with the hearing. The Request for Hearing was withdrawn. The Department agreed to the dismissal of the hearing request.
