HEARING DECISION

Pursuant to a September 8, 2014, federal lawsuit, the Department of Health and Human Services (Department) issued notices to Medicaid applicants who were potentially denied full Medicaid coverage based on immigration status between January 2014 and May 2015. The notice included information about how to request a hearing. Petitioner filed a request for a hearing; and accordingly, this matter is before the undersigned Administrative Law Judge pursuant to Michigan Administrative Hearing Rules (R 792.10101 – R 792.11903) and the Administrative Procedures Act, 1969 PA 306, as amended, MCL 24.201 *et seq.*

ISSUE

Did the Department properly determine Petitioner's immigration status or citizenship when determining Medicaid (MA) eligibility?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On **Example 1**, Petitioner applied for MA and also sought retro-active MA for the months of **Example 2**. On the date of MA application or redetermination, Petitioner was not a United States (U.S.) citizen.

- 2. Beginning ______, the Department corrected the Petitioner's MA eligibility to full-coverage MA case. Based upon the fact that he is a U.S. citizen.
- 3. The Petitioner, in his application for MA, advised the Department that he was a U.S. citizen.
- 4. On a date unknown, the Department issued a notice to the Petitioner indicating he/she might have been denied full MA coverage based on immigration status between .
- 5. On Petitioner requested a hearing.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), Department of Health and Human Services Modified Adjusted Gross Income (MAGI) Related Eligibility Manual (MREM), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, Petitioner requested a hearing because he was initially granted Emergency Services Only (ESO) MA even though he was a U.S. citizen since The Department ultimately corrected the Petitioner's coverage to full MA. Ultimately, the Department closed the Petitioner's case in the former of the failure to complete and return the Redetermination. Based upon the proofs presented at the hearing, the Department established that the Petitioner was a U.S. citizen at the time of his MA application and that it ultimately corrected his MA coverage to full coverage Medicaid.

At all times pertinent to the application and this matter, the Petitioner was a United States citizen and indicated the same on his MA application. Although, the Department ultimately closed the Petitioners MA case that closure happened after the period to be reviewed as part of Petitioner's hearing request in this case and thus is not an issue to be decided in this matter and was not based upon the Petitioner's immigration status.

To be eligible for full MA coverage a person must be a U.S. citizen or an alien admitted to the U.S. under a specific immigration status. BEM 225 (October 1, 2015), p. 32.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department <u>did</u> properly determine Petitioner's immigration status or citizenship when determining MA eligibility.

DECISION AND ORDER

Accordingly, the Department's determination about MA eligibility based on immigration status is **AFFIRMED**.
