**HEARING DECISION**

Pursuant to a [REDACTED], federal lawsuit, the Department of Health and Human Services (Department) issued notices to Medicaid applicants who were potentially denied full Medicaid coverage based on immigration status between [REDACTED] and [REDACTED]. The notice included information about how to request a hearing. Petitioner filed a request for a hearing; and accordingly, this matter is before the undersigned Administrative Law Judge pursuant to Michigan Administrative Hearing Rules (R 792.10101 – R 792.11903) and the Administrative Procedures Act, 1969 PA 306, as amended, MCL 24.201 *et seq.*

After due notice, a telephone hearing was held on [REDACTED], from Detroit, Michigan. The Petitioner was represented by himself. The Department was represented by [REDACTED] Assistance Payments Worker. [REDACTED] served as translator during the hearing.

**ISSUE**

Did the Department properly determine Petitioner's immigration status or citizenship when determining Medicaid (MA) eligibility?

**FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On [REDACTED], Petitioner applied for MA or had a Redetermination of current MA benefits.
2. On the date of MA application or redetermination, Petitioner was a United States (U.S.) citizen. Exhibit 1.

3. Beginning [REDACTED], the Department granted the Petitioner **full-coverage MA based upon the fact that he was a United States citizen. Exhibits 2 and 4.**
4. On an unknown date, the Department issued a notice to the Petitioner indicating he/she might have been denied full MA coverage based on immigration status between [REDACTED] and [REDACTED].
5. On [REDACTED], Petitioner requested a hearing.

### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), Department of Health and Human Services Modified Adjusted Gross Income (MAGI) Related Eligibility Manual (MREM), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

In this case, Petitioner requested a hearing to determine whether the Department properly assigned him full coverage MA based upon the fact that he had full U.S. citizenship since [REDACTED] Exhibit 2.

At all times pertinent to the application and this matter, the Petitioner was a U.S. citizen and indicated the same on his MA application. Although, the Department recently closed the Petitioner's MA case, that closure happened after the period to be reviewed as part of Petitioner's hearing request in this case; and thus, there is no issue to be decided in this matter because the closure of Petitioner's MA was not based upon the Petitioner's immigration status or U.S. citizenship.


To be eligible for full MA coverage a person must be a U.S. citizen or an alien admitted to the U.S. under a specific immigration status. BEM 225 (October 1, 2015), p. 32. Based upon the evidence presented in this case it is determined that the Department correctly determined the Petitioner's medical assistance coverage at the time of the application based on his U.S. citizenship there is nothing further for the undersigned to resolve as the Petitioner was and is a U.S. citizen and had full coverage MA throughout the period [REDACTED] through [REDACTED].

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department **did** properly determine Petitioner's immigration status or citizenship when determining MA eligibility.

**DECISION AND ORDER**

Accordingly, the Department's determination about MA eligibility based on immigration status is **AFFIRMED**.
