HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10. After due notice, telephone hearing was held on May 26, 2016, from Lansing, Michigan. Participants on behalf of Petitioner included [REDACTED]. [REDACTED] (Family Independence Manager) represented the Department of Health and Human Services (Department).

ISSUE

Did the Department of Health and Human Services (Department) properly deny the Petitioner's Medical Assistance (MA) application?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. On February 3, 2016, the Department received the Petitioner's Medical Assistance (MA) application.
2. On February 3, 2016, the Department sent the Petitioner a Health Care Coverage Supplemental Questionnaire (DHS-1004) with a due date of February 16, 2016. Exhibit A, 6 – 8.
3. On February 3, 2016, the Department sent the Petitioner a Verification Checklist (DHS-3503) requesting proof of all income received over the previous 30 days by February 16, 2016. Exhibit A, pp 9 – 10.

4. On February 16, 2016, the Department notified the Petitioner that it had denied his Medical Assistance (MA) application. Exhibit A, pp 11 – 13.
5. On April 15, 2016, the Department received the Petitioner's request for a hearing protesting the denial of his Medical Assistance (MA) application. Exhibit A, pp 3 – 4.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

Clients must cooperate with the local office in determining initial and ongoing eligibility and this includes the completion of necessary forms. Department of Human Services Bridges Assistance Manual (BAM) 105 (July 1, 2015), p 8.

Verification means documentation or other evidence to establish the accuracy of the client's verbal or written statements. Verification is usually required at application/redetermination and for a reported change affecting eligibility or benefit level when it is required by policy, required as a local office option, or information regarding an eligibility factor is unclear, inconsistent, incomplete, or contradictory. The Department uses documents, collateral contacts, or home calls to verify information. A collateral contact is a direct contact with a person, organization, or agency to verify information from the client. When documentation is not available, or clarification is needed, collateral contact may be necessary. Department of Human Services Bridges Assistance Manual (BAM) 130 (January 1, 2016), pp 1-9.

On February 3, 2016, the Department received the Petitioner's MA application. The Department sent the Petitioner a Health Care Coverage Supplemental Questionnaire (DHS-1004) and a Verification Checklist (DHS-3503) requesting that they be completed and returned by February 16, 2016. When the Department did not receive these forms from the Petitioner, it notified him on February 16, 2016, that his MA application had been denied.

The Petitioner had a duty to supply the Department with the information necessary to accurately determine his eligibility for MA benefits. When the required forms were not returned in a timely manner, the Department was acting in accordance with policy when it denied the Petitioner's application for benefits.

If the Petitioner has been approved for disability benefits by the Social Security Administration (SSA), he may be eligible to apply for retroactive benefits, but a new application will be required.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it denied the Petitioner's February 3, 2016, application for Medical Assistance (MA).

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
