HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on May 25, 2016, from Lansing, Michigan. Petitioner appeared and testified. PATH Coordinator [REDACTED] and Family Independence Specialist [REDACTED] appeared for the Department and testified. Department's Exhibit A, pages 1-27 was admitted into evidence.

ISSUE

Did the Department properly sanction Petitioner's Family Independence Program (FIP) and Food Assistance Program (FAP) beginning March 1, 2016?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

1. Petitioner was an ongoing recipient of Family Independence Program (FIP) and Food Assistance Program (FAP) benefits.
2. On December 21, 2015, PATH placed Petitioner on medical inactive status.
3. On January 19, 2016, PATH assigned Petitioner to triage.
4. On January 25, 2016, Petitioner was sent a Notice of Noncompliance (DHS-2444) which scheduled a triage meeting for February 2, 2016. Petitioner was also sent a Notice of Case Action (DHS-1605) which stated her Family Independence

Program (FIP) and Food Assistance Program (FAP) would be sanctioned March 1, 2016.

5. On February 2, 2016, Petitioner attend the triage meeting.
6. On February 4, 2016, Petitioner submitted a hearing request.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Pub. L. No. 104-193, and 42 USC 601 to 679c. The Department (formerly known as the Department of Human Services) administers FIP pursuant to 45 CFR 233-260, MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3101-.3131.

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

During this hearing the Department representatives testified credibly that they have medical documentation which shows that Petitioner should not be sanctioned. No further analysis is required to decide this case. The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department failed to satisfy its burden of showing that it acted in accordance with Department policy when it sanctioned Petitioner's Family Independence Program (FIP) and Food Assistance Program (FAP) beginning March 1, 2016.


DECISION AND ORDER

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Re-instate Petitioner's Family Independence Program (FIP), remove the sanction from both programs and supplement Petitioner any benefits she was otherwise eligible for but did not receive due to this incorrect action.
