## **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a/an telephone hearing was held on from Detroit, Michigan. The Petitioner was represented by Petitioner. The Department of Health and Human Services (Department) was represented by Family Independence Manager. The Department supplied as interpreter.

#### **ISSUE**

Did the Department properly close the Respondent's Family Independence Program (FIP)?

#### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- On processing, the Department closed the Petitioner's FIP benefits due to the Petitioner's failure to comply with Partnership.Accountability.Training.HOPE. (PATH) requirements.
- 2. This same issue was the subject of a decision dated that the Petitioner had failed to comply with PATH.
- 3. On the Petitioner requested another hearing to protest the denial of his FIP benefits for noncompliance with PATH.

## **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Family Independence Program (FIP) was established pursuant to the Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Pub. L. No. 104-193, and 42 USC 601 to 679c. The Department (formerly known as the Department of Human Services) administers FIP pursuant to 45 CFR 233-260, MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3101-.3131.

In this case, the Petitioner requested a hearing to protest the same issue in the hearing that was held on good cause for the Petitioner not to go to PATH. (BEM 233A).

At this hearing, this ALJ asked the Petitioner what had changed to allow a finding of good cause for missing PATH. The Petitioner testified that a number of the facts had changed but that he was not prepared to present evidence of such changes.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it failed to find good cause for the Petitioner to miss PATH.

#### **DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.

A party may request a rehearing or reconsideration of this Order if the request is received by MAHS within 30 days of the date the Order was issued. The party


requesting a rehearing or reconsideration must provide the specific reasons for the request. MAHS will not review any response to a request for rehearing/reconsideration.
