## **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on July 13, 2016, from Lansing, Michigan. The Petitioner was represented by himself. The Department of Health and Human Services (Department) was represented by Assisted Payments Supervisor and Eligibility Specialist.

# **ISSUE**

Did the Department properly determine that the Petitioner was not eligible for Food Assistance Program (FAP) benefits because he was convicted of 2 drug felonies since August 22, 1996?

### FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. The Petitioner was a recipient of FAP benefits.
- 2. On May 24, 2016, the Department Caseworker received a FEE Investigation requesting that the Petitioner FAP case be closed due to multiple drug related felonies. Department Exhibit 1, pgs. 1-2.
- 3. On May 24, 2016, the Department Caseworker sent the Petitioner a notice that his FAP case was pended to close on July 1, 2016 due to him not being eligible for FAP benefits due to conviction of at least 2 drug related felonies since August 22, 1996, which results in permanent disqualification for FAP benefits. Department Exhibit 1, pgs. 3-6.

4. On June 14, 2016, the Department received a hearing request from the Petitioner, contesting the Department's negative action.

# **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Food Assistance Program (FAP) [formerly known as the Food Stamp program] is established by the Food and Nutrition Act of 2008, as amended, 7 USC 2011 to 2036a and is implemented by the federal regulations contained in 7 CFR 273. The Department (formerly known as the Department of Human Services) administers FAP pursuant to MCL 400.10, the Social Welfare Act, MCL 400.1-.119b, and Mich Admin Code, R 400.3001-.3011.

In this case, the Petitioner was a recipient of FAP benefits. On May 24, 2016, the Department Caseworker received a FEE Investigation requesting that the Petitioner FAP case be closed due to multiple drug related felonies. Department Exhibit 1, pgs. 1-2. On May 24, 2016, the Department Caseworker sent the Petitioner a notice that his FAP case was pended to close on July 1, 2016 due to him not being eligible for FAP benefits due to conviction of at least 2 drug related felonies since August 22, 1996, which results in permanent disqualification for FAP benefits. Department Exhibit 1, pgs. 3-6. On June 14, 2016, the Department received a hearing request from the Petitioner, contesting the Department's negative action. BEM 203.

During the hearing, the Department submitted written verification that the Petitioner has been convicted of two drug felonies after August 22, 1996 with the first conviction of November 9, 1998 and the second on May 3, 1999. Department Exhibit 1, b-d. The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed the Petitioner's FAP case because he had 2 felony drug convictions since August 22, 1996, which banned him from receiving FAP benefits for a lifetime.

### **DECISION AND ORDER**

Accordingly, the Department's decision is **AFFIRMED**.
