### **HEARING DECISION**

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on September 15, 2016, from Lansing, Michigan. Petitioner was represented by herself. The Department was represented by Hearing Facilitator. Testimony was received from all participants. Department's Exhibit A, pages 1 - 35 was admitted into evidence.

#### **ISSUE**

Did the Department properly determine Petitioner's Medical Assistance (MA) eligibility on June 29, 2016?

# **FINDINGS OF FACT**

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- 1. On June 29, 2016, Petitioner was sent a Health Care Coverage Determination Notice (DHHS-1606) which stated she was not eligible for Medical Assistance (MA) from April 1 30, 2016 but was eligible May 1, 2016 ongoing.
- 2. On August 11, 2016, Petitioner submitted a hearing request.

#### **CONCLUSIONS OF LAW**

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The Medical Assistance (MA) program is established by Title XIX of the Social Security Act, 42 USC 1396-1396w-5; 42 USC 1315; the Affordable Care Act of 2010, the collective term for the Patient Protection and Affordable Care Act, Pub. L. No. 111-148, as amended by the Health Care and Education Reconciliation Act of 2010, Pub. L. No. 111-152; and 42 CFR 430.10-.25. The Department (formerly known as the Department of Human Services) administers the MA program pursuant to 42 CFR 435, MCL 400.10, and MCL 400.105-.112k.

During this hearing Petitioner testified that she was covered under private health insurance on April 1, 2016 and has income from an annuity. The Department representative testified that these facts were not part of the June 29, 2016 Medical Assistance (MA) eligibility determination but would have an impact on Petitioner's Medical Assistance (MA) eligibility.

The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department failed to satisfy its burden of showing that it acted in accordance with Department policy when it determined Petitioner's Medical Assistance (MA) eligibility on June 29, 2016.

## **DECISION AND ORDER**

Accordingly, the Department's decision is **REVERSED**.

THE DEPARTMENT IS ORDERED TO BEGIN DOING THE FOLLOWING, IN ACCORDANCE WITH DEPARTMENT POLICY AND CONSISTENT WITH THIS HEARING DECISION, WITHIN 10 DAYS OF THE DATE OF MAILING OF THIS DECISION AND ORDER:

1. Re-determine Petitioner's Medical Assistance (MA) eligibility from April 1, 2016 and issue a current notice of the Medical Assistance (MA) eligibility.
