**ORDER OF DISMISSAL PURSUANT TO
WITHDRAWAL OF HEARING REQUEST AT HEARING**

This matter is before the Michigan Administrative Hearing System upon Petitioner's request for hearing made pursuant to MCL 400.9 and MCL 400.37, and Titles 7, 42, and 45 of the Code of Federal Regulations, which govern the administrative hearing and appeal process. After due notice, a telephone hearing was commenced on [REDACTED] [REDACTED] from Detroit, Michigan. The Petitioner was represented by [REDACTED] (Petitioner). The Department of Health and Human Services (Department) was represented by [REDACTED], Hearings Facilitator.

On [REDACTED], the Department timely received a Redetermination (DHS-1010) for his Food Assistance Program (FAP), Medical Assistance (MA), and Medicare Savings Program (MSP) benefits. Exhibit A, pp. 1 and 5-10 (Hearing Summary and Redetermination). However, the Department closed Petitioner's FAP, MA, and MSP benefits effective [REDACTED].

As result of the program closures, on [REDACTED], Petitioner filed a hearing request, protesting the Department's action. Exhibit A, pp. 2-3.

Shortly after commencement of the hearing, it was discovered that the Department reinstated Petitioner's FAP, MA, and MSP benefits from [REDACTED], which resulted in no lapse in coverage. Petitioner did not dispute that the FAP, MA, and MSP benefits had been reinstated and that there had been no lapse in coverage.

Based on the foregoing information and evidence, Petitioner's FAP, MA, and MSP benefits hearing request is moot because the Department conducted subsequent actions in which it resolved his dispute. As a result, Petitioner did not wish to proceed with the hearing. The Request for Hearing was withdrawn. The Department agreed to the dismissal of the hearing request.

Pursuant to the withdrawal of the hearing request filed in this matter, the Request for Hearing (dated [REDACTED]) is, hereby, **DISMISSED**.
