HEARING DECISION

Following Petitioner's request for a hearing, this matter is before the undersigned Administrative Law Judge pursuant to MCL 400.9 and 400.37; 7 CFR 273.15 to 273.18; 42 CFR 431.200 to 431.250; 45 CFR 99.1 to 99.33; and 45 CFR 205.10; and Mich Admin Code, R 792.11002. After due notice, a telephone hearing was held on October 6, 2016, from Lansing, Michigan. Petitioner was represented by herself. The Department was represented by Eligibility Specialist and Assistance Payments Supervisor. Testimony was received from all participants. Department's Exhibit A, pages 1-22 was admitted into evidence.

ISSUE

Did the Department properly close Petitioner's State Disability Assistance (SDA) beginning October 1, 2016?

FINDINGS OF FACT

The Administrative Law Judge, based on the competent, material, and substantial evidence on the whole record, finds as material fact:

- Petitioner was an ongoing recipient of State Disability Assistance (SDA) benefits.
 Petitioner was eligible for the benefits because she was working with Michigan Rehabilitative Services (MRS).
- 2. On June 17, 2014, Petitioner's MRS case was closed due to her failure to participate in the approved employment plan.
- 3. On August 25, 2016, Petitioner was sent a Notice of Case Action (DHHS-1605) which stated her State Disability Assistance (SDA) would end October 1, 2016.

4. On September 2, 2016, Petitioner submitted a hearing request.

CONCLUSIONS OF LAW

Department policies are contained in the Department of Health and Human Services Bridges Administrative Manual (BAM), Department of Health and Human Services Bridges Eligibility Manual (BEM), Department of Health and Human Services Reference Tables Manual (RFT), and Department of Health and Human Services Emergency Relief Manual (ERM).

The State Disability Assistance (SDA) program is established by the Social Welfare Act, MCL 400.1-.119b. The Department of Health and Human Services (formerly known as the Department of Human Services) administers the SDA program pursuant to 42 CFR 435, MCL 400.10 and Mich Admin Code, R 400.3151-.3180.

Bridges Eligibility Manual (BEM) 261 Disability – SDA provides that a person is eligible for SDA benefits if they are receiving MRS services. It also provides that "A person is receiving services if he has been determined eligible for MRS and has a signed active individual plan for employment (IPE) with MRS."

Petitioner's MRS case was closed on June 17, 2014 so she no longer has a signed active individual plan for employment (IPE) with MRS. The Administrative Law Judge, based on the above Findings of Fact and Conclusions of Law, and for the reasons stated on the record, if any, finds that the Department acted in accordance with Department policy when it closed Petitioner's State Disability Assistance (SDA) beginning October 1, 2016.

DECISION AND ORDER

Accordingly, the Department's decision is **AFFIRMED**.
